Dear Members of the Charter Revision Commission,

On behalf of the Board of Selectmen, I am respectfully requesting your commission consider adding two additional "at large" members to the Open Space Committee to be chosen by the Board of Selectmen.

On February 22, 2016 the Board of Selectmen held a public hearing on a proposed Amendment to Chapter 21 of the Simsbury Code of Ordinances, the Agricultural Land Preservation and Land Acquisition Fund, inserting a new Section 21-8 Process and Criteria for Disposition of Open Space Land. During public comment, a number of residents expressed their strong support for maintenance and stewardship of Simsbury's open space and several suggested that the Open Space Committee be expanded with additional "at large" members. The additional members may add expertise on stewardship or land management that could be beneficial to discussions and recommendations in the future.

The existing Cushman Utility Vehicle is essential in setting up, operating and tearing down concerts. It is unreliable, and repairs take time. We have asked that it be replaced, and the old one will be kept for backup. We need the redundancy to avoid day of concert emergency situations.
