#### **Guidelines for the Hometown Hero Program**

Adopted by Board of Selectmen November 13, 1996 Amended February 23, 1998 Amended March 26, 2018 Amended March 25, 2024

#### 1. Background Information

The Program was initiated in 1986 by Governor William O'Neill as part of the 350th Anniversary of the founding of Connecticut. Any municipality could designate residents as "Hometown Heroes" for any deed or service that made the community a better place in which to live. State certificates were presented to the 42 individuals and 4 organizations on May 12, 1986. The following year, First Selectwoman Margaret Shanks continued the program with certificates developed for Simsbury, naming 48 designates. It has been continued since, with Hometown Heroes recognized at a ceremony during the month of May as May 12th is the date of Simsbury's birth.

#### 2. Criteria for Selection

- A. A person(s) who is a resident, or who is active in the Simsbury community, or who lived in Simsbury during the time period that is under consideration.
- B. That the acts and services which are recognized have a real and perceived benefit to the Town of Simsbury; and that
- C. Individuals or groups that have been nominated for the Hometown Hero Award shall be duly considered with the following exception:

A nominee may not be a member of Town staff, nor a sitting elected official, or have benefited economically from his/her endeavors on behalf of the Town. Provided however that no nominee shall excluded from consideration when the qualities and activities under consideration are outside the scope of their official duties.

D. There will be no quotas or automatic selections by the Committee and the Committee shall use discretion to protect the special significance of the award when considering large numbers of nominees.

#### 3. The Selection Process

A. Written nominations will be requested and received during a thirty (30) day period typically occurring in whole or part during the months of March and/or April.

- B. The Selection Committee shall review the names nominated for the Hometown Hero Award. The Committee shall make selection and approve the list of award recipients no later than two weeks prior to the scheduled ceremony.
- C. The Town Manager's Office shall notify all award recipients of the time and place of the award ceremony.
- D. The Town Manager's Office shall complete arrangements for the ceremony such as scheduling, publicity, and refreshments.
- E. The names of award recipients will be engraved on the Hometown Heroes plaque displayed in Town Hall.

#### 4. The Selection Committee

The Selection Committee shall be appointed by the Board of Selectmen on a biennial basis. The Selection Committee shall consist of the First Selectman, a Board of Selectmen member of the opposite party, a member of the Historical Society, a business leader, a previous hometown hero, and a member of a veterans or service organization, with the goal of non-partisanship in mind.

The membership of the Committee shall be recommended by the First Selectman and the Town Manager to the Board of Selectmen. The Board of Selectmen is the appointing authority.

Staff assistance to the Selection Committee shall include reasonable requests deemed necessary by the Committee.

Mark Orenstein is a good friend, colleague, and my own personal hero. I believe he deserves this recognition from Town due to his unyielding commitment to improve the community for every single person. Mark has devoted many days of his life inside Town Hall, the Public Library, SCM Studio, Historical Society, and many other places, improving the facilities, specifically with networking and technology, to better serve the community he's so loyal to. Honestly, Mark has done so many good deeds, that it's hard to only give just one example.

In my time of knowing Mark, not only has he been a reliable camera person, covering various Board Meetings and Town events (fun fact, Mark recorded last years Home Town Hero award for rebroadcast on SCM!), but a passionate teacher, eager to pass on the knowledge with kindness and compassion. (You know you ask a good question when he starts grinning ear to ear).

In my time of knowing Mark, he has made various improvements to the live-streaming infrastructure located in Town Hall. Making it easier for volunteers to learn equipment and live-stream Town meetings. This includes networking improvements, robotic cameras, over-head ceiling microphones, wireless microphones, computers, and more. When SCTV didn't have the funding for a broadcast playback system, Mark setup various Raspberry Pi computers to continue the SCTV broadcast, even though we didn't have the funding at the time to replace the broken playback system. Mark's Raspberry Pi solution cost \$100. For reference a new broadcast system costs in the ball park of \$20,000. This was such an accomplishment that it was featured in a 2017 issue of "Valley Life", with a picture of Mark proudly in front of his Raspberry Pi broadcast system that he invented for us. We eventually managed to get a grant to replace the Raspberry Pi system with a modern playback system. Mark was instrumental and making this happen. Mark regularly reviews grant packets for SCM and the library to make sure that the technology needs of the organizations are met and are budgeted fairly. I'm sure the person reading this knows who Mark Orenstein is and chances are he's impacted your life in one way or another.

Mark has mentored me throughout my time in Simsbury, and in that time, not only has he taught me the life skills I need to know to reliably carry out my duties as Station Manager of SCM, but he's taught me important life lessons that I'll carry with me for the rest of my life.

Please consider Mark Orenstein for the Simsbury Hometown Hero.

Mark is my hero and he should be yours, too.

Jenna Caulfield's investment in the Simsbury community dates to the mid-2000s when she started volunteering with the Simsbury Farmers Market that ran for many years near Big Sky on Hopmeadow. She developed relationships with leaders of that initiative and Simsbury's Main Street Partnership that continue to pay dividends today.

Her desire to make a difference in the community grew and diversified in subsequent years. Her near-constant involvement in Latimer Lane Elementary since 2013 included three years as co-president of the PTO and involvement in myriad committees and initiatives that improved the experiences of the school's children, teachers, fellow parents, and administrators. She was selected by the Board of Education as one of a select group of parent volunteers to offer counsel during the COVID pandemic, during which she helped ensure parental feedback was considered, emerging issues during a very difficult time received fair consideration by educational and governmental leaders, and that the community was kept informed throughout.

In 2019, Jenna applied to join the Simsbury Police Commission and has served as the "unaffiliated" member of that critical volunteer organization ever since, including multiple years as the chairperson. She developed a keen understanding of policing needs and issues, as well as town business practices such as budgeting and other legislative undertakings. Her investment in learning the ins and outs of her role was only eclipsed by her building of relationships with the people across town operations, including and most importantly the police department. She did all of this without fanfare and with ample goodwill from those with whom she interacted.

This year, Jenna added "poll worker" to her list of community contributions, as she joined the Simsbury operation for Connecticut's primary day on April 2 and will do so again for the general election in November. She also joined friends over the last year in working to support the "Journey Home" charity that helps disadvantaged families find or improve their living arrangements.

She is often recognized by town officials, residents, and friends for, as one person put it, "giving her full heart to every endeavor she undertakes" and for being "an excellent and patient resource for all things municipal and police related."



The Simsbury Loan Locker is a local source for durable medical equipment to meet the growing needs for those in our community who are experiencing a temporary or permanent disability. Over 3300 transactions have been serviced by the Simsbury Loan Locker's all-volunteer team since its start in early 2020. The captain of this team, and our nominee for Hometown Hero, is Alan Needham.

The Simsbury Loan Locker was the idea of Alan Needham several years ago. Alan engaged the appropriate collaborators, including the Aging and Disability Commission, the Simsbury/Granby Rotary, and a cadre of Town resources, to make the Loan Locker a reality. Alan secured space, recruited volunteers, and created protocols to make wheelchairs, walkers, canes, knee scooters, bed rails, and more, available for temporary use, free of charge. This reduces the costs and anxiety of someone facing surgery or recovering from injury. It also supports disabled clients who have equipment that needs repair or have just learned of their need for new devices. It also promotes re-use of equipment that might otherwise be discarded.

Alan oversees the organizational and every day, year-round, operations of the Loan Locker. His congenial style draws in volunteers who are essential for this service to clients who are at their most vulnerable and challenged due to their physical limitations or those of a loved one.

Alan has been involved in the Simsbury community for decades. The Loan Locker is only his most recent gift from which residents of Simsbury, and surrounding towns, benefit. Thank you, Alan!

The Simsbury Loan Locker, which to date has served more than 3300 people, is the brainchild of Alan Needham. Alan and his wife Johanna provided end of life care to her mother Evelyn in their home in 2018, requiring the purchase and rental of a large amount of durable medical equipment.

That experience inspired Alan to establish an organization that would help members of the community share items like wheelchairs, walkers, bed rails and shower chairs that often sit unused in closets and basements after they are used. Collaborating with town staff, Alan secured space and donations, recruited volunteers and developed a system for residents to donate and borrow equipment.

Since the Loan Locker opened its doors to the public in 2019, Alan has coordinated a team of volunteers who receive, sanitize, inventory and distribute needed items. And though he and Johanna now live just across the town line in Avon, Alan donates many hours of his time each week managing inquiries from Simsbury residents and coordinating with volunteers to respond to requests for equipment.

He is the 2021 recipient of the Paul Harris Award for Civic Achievement from the Simsbury-Granby Rotary Club, and he continues community outreach to promote Loan Locker services.

In addition to his work with the Loan Locker, Alan previously served as an elected official on the Simsbury Planning Commission for more than a decade. He is the proud grandfather to his grandsons Emmet and Jacob, father to John and Allyson, and husband to the amazing Johanna.

Bob and I worked closely for the town's 100 year celebration and my name is in a capsule buried at the Historical society to be opened 100 years from that date. John E. I was president of the Simsbury Junior Achievement and had a successful business which we called Tycoon enterprise and I was asked to speak at the Simsbury Rotary club. I believe at the time they said that I was the only female to attend their meeting.

I then became President of the Simsbury Chamber of Commerce and enjoyed the interaction with the town officials.

A fun and fond memory ..... My Father owned Rossetti paving and I was the last person to pave the Drake hill bridge., now known as the flower bridge. Russell Shaw presented me with an award as well as the Governor and standing in my office from the State of Connecticut is a certificate from the General Assembly official Citation.

I want to add that I never did a show without mentioning and Thanking my Dear parents Andrew and Mary Rossetti for believing in me and giving me the opportunity to Dance my way through life. My greatest accomplishment was On April 13 , 1978 when Bob and I were blessed with our son Robertson Joseph-andrew Michaud. He is my number one priority along with my three grandchildren.
