July 11, 2011

CALL TO ORDER

The Regular Meeting of the Board of Selectmen was called to order at 7:00 p.m. in the Main Meeting Room of the Simsbury Town Offices. Present were: First Selectman Mary Glassman; Board members John Hampton, Lisa Heaver and Robert Hensley. Absent were Moira Wertheimer and Nancy Haase. Others in attendance included Colleen O'Connor, Tom Roy, Hiram Peck and other interested parties.

PLEDGE OF ALLEGIANCE

**PRESENTATION** 

Route 10 Corridor Study Update - Accept Draft Report and begin 30-day public comment period

Ms. Glassman said the Route 10 Corridor draft report was being formally submitted to the Board. This document shows short term improvements and long with 10/20/30 year visions. There are a number of suggestions and a lot of information in this study. Once the Board accepts the draft the 30 day public comment period begins. Ms. Glassman said the drafts are also available at the Library and Town Hall for public review. She thanked everyone who worked so hard on this project.

Mr. Peck said the document maintains the two lane character of Rte. 10, which was very important to the residents. He said the first chapter is the vision of the Town; the second chapter is standard assessments; and chapter 3 is action and alternatives. He said it is very important for the public to know comment on the draft report. He also thanked everyone who worked so hard on this document. If anyone has specific questions they can contact Mr. Peck. Also, comments can be given on the Town website and CROCG website.

After further discussion, Mr. Hampton made motion to accept the Route 10 Corridor Study Document from the Steering Committee to begin the 30-day public comment period. Mr. Hensley seconded the motion. All were in favor and the motion passed.

# PUBLIC AUDIENCE

Mr. Kalechman, 971 Hopmeadow Street, said he went to the Library Saturday after 1 pm and found it closed. He can't understand why the Library closes at 1 pm in the summer as a lot of elderly residents could go there to get cool and relax.

Mr. Kalechman asked why the Tax payments are being sent to Mass. He doesn't think the Town money should be used in Mass.

Mr. Kalechman also doesn't like that the Town only uses Simsbury Bank. He feels the money should be spread out in different banks and this should be looked in to.

Joan Coe, 26 Whitcomb Drive, asked why September Fest was moved to Simsbury Meadows. She feels this location is not really accessible to wheelchairs, strollers, etc.

Ms. Coe complained about signs at the new Dunkin Donuts at the South End. She said they went against the Town Sign Policy but putting up big signs for their opening.

Ms. Coe spoke again about allowing the public to vote for a Town Manager form of government. She asked that the Charter Revision Commission look into this further. She would also like Boards and Commission decreased in size and this should be looked at again.

Ms. Coe doesn't understand why Westminister School makes yearly donations for their tax exempt status and Ethel Walker doesn't even though they are tax exempt.

### FIRST SELECTMAN'S REPORT

Ms. Glassman said the paving of Rte. 10 should be completed by the end of the week. She thanked Richard Sawitzke and the DOT for all their hard work on this project. Ms. Glassman said the Town budget moves forward as proposed. After hard work by State Representative Linda Schofield, working with a coalition of other Legislators, the elimination of any cuts to municipal funding was saved.

Ms. Glassman encouraged everyone to join in the fight to save the Tariffville Post Office. There will be a rally tomorrow at 6 p.m. at the Tariffville Village Green Gazebo and they could use everyone's support. Also, she asked everyone to continue to send letters to save this Post Office.

Ms. Glassman said that the "Receptionist" area will be filled with volunteers now. She thanked Mickey Lecours-Beck for her help in securing dedicated volunteers that will met and greet people coming into Town Hall and help them to find their way to the correct office. She asked everyone to say hello to the volunteers and thanked Mary Donahue, Pauline Henderson, Jack Voorvart or

Ron Locandro and thank them for their volunterism.

#### SELECTMEN'S ACTIONS

## a) Approve Tax Refunds

Ms. O'Connor noted that none of Simsbury tax money is going to Mass. Simsbury Bank has their processing center in Mass and they process all of the tax money and deposit it on the same day. This allowed the Town's Tax Dept. to only have to hire one employee for the summer instead of three. She also noted that the Town does use other banks.

Mr. Hampton made motion to approve the tax refunds in the amount of \$1,227.31 as requested and recommended by the Tax Collector. Ms. Heavner seconded the motion. All were in favor and the motion passed.

b) Approve the contingent appointment of Mary Ann Harris as Director of Finance - Treasurer

Ms. Heavner made motion to approve the appointment of Mary Ann Harris to the position of Director of Finance-Treasurer subject to successful completion of pre-employment screening and approval of the Board of Finance. Mr. Hensley seconded the motion. All were in favor and the motion passed.

c) Authorize the First Selectman to execute a resolution for a Supplemental

Government Grant Application

Mr. Hampton made motion: RESOLUTION for Historic Preservation Enhancement Grant Application

WHEREAS, Supplemental Certified Local Government Grants is a White House initiative developed in cooperation with the Advisory Council on Historic Preservation, the Department of the Interior, and other Federal agencies; and is administered by the National Park Service, U.S. Department of Interior; and

WHEREAS, Supplemental Certified Local Government Grants offer a new type of funding from the Community Investment Act to support local historic preservation programs in communities with the Certified Local Government designation from the National Parks Service; and

WHEREAS, a Historic Resource Survey is an example of historic preservation program providing archival research, fieldwork and photography of historic properties in the town; and

WHEREAS, The Town of Simsbury has resolved to support a Supplemental Certified Local Government Grant by vote of this Board of Selectmen on July 11, 2011, based on its inclusion in the Certified Local Government in Federal Historic Preservation Program; and now therefore be it

RESOLVED, that the Town of Simsbury will accept this grant, if awarded, and will remain committed to this project through its completion.

Mr. Hensley made motion to accept \$56,726.45 FEMA Reimbursement (Public Assistant Grant) for costs incurred during the January 11-12,2011 Severe

Snowstorm Disaster. Mr. Hampton seconded the motion. All were in favor and the motion passed.

Mr. Hampton made motion to transfer \$25,365.00 from reserves to accounts as presented by Mr. Roy in his June 20, 2011 memo for the Severe Snowstorm Disaster. Mr. Hensley seconded the motion. All were in favor and the motion passed.

e) Accept Memorandum of Agreement regarding use of Federal Fiscal Year 2010 State Homeland Security Grant Funding and Custodian Ownership of Regional Assets in DEMHS Region 3 and execute Authorizing Resolution

Mr. Hensley made motion:

RESOLVED, that the Town of Simsbury may enter into with and deliver to the State of Connecticut Department of Emergency Management and Homeland Security any and all documents which it deems to be necessary or appropriate; and

FURTHER RESOLVED, Mary G. Glassman, First Selectman of the Town of Simsbury, is authorized and directed to execute and deliver any and all documents on behalf of the Town of Simsbury and to do and perform all acts and things which she deems to be necessary or appropriate to carry out the terms of such documents, including, but not limited to, executing and

delivering all agreements and documents contemplated by such documents.

Mr. Hampton seconded the motion. All were in favor and the motion passed.

### OTHER BUSINESS

Acknowledge receipt of \$98,000 check from Westminister School honoring their long standing relationship with the Town of Simsbury

Ms. Glassman noted that this is not something the School has to pay, but always pays in lieu of their tax-exempt status.

Ms. Heavner made motion to accept the \$98,000 check from Westminister School with thanks. Mr. Hensley seconded the motion. All were in favor and the motion passed.
