

Enter the Old Drake Hill Flower Bridge 2015 Photo Contest

Registration Form

Who can enter? Anyone.

Subject matter? Pictures and photomontages of pictures taken at the Old Drake Hill Flower Bridge as your eye sees it. The bridge is located over the Farmington River at 1 Old Bridge Road, Simsbury, CT 06070.

When? Photos must be taken between June 1, 2015 and September 1, 2015 and submitted in reprintable form. All submissions are to be in finished dimensions of 5.5" x 4.25" horizontally or vertically oriented without a border or frame. Entries need to arrive not later than September 5, 2015 at **P.O. Box 314 West Simsbury, 06092** or at email flowerbridgephoto@gmail.com. If submitted in digital form, the format needs to be a .jpeg with a resolution of no less than 600 d.p.i.

What happens to your photo? If your photo/s is/are chosen as any of the winning four photos, your photo/s will be published on the new edition of the Old Drake Hill Flower Bridge note cards scheduled to go on sale in the fall of 2015 with you identified on the note card as the photographer. The winning entries may also be used as graphics for posters, T shirts, etc., again, with you identified as the photographer. Thus, **upon submission you must relinquish any and all rights to the image and allow it to be used and reproduced by the Old Drake Hill Flower Bridge (ODHFB) as it sees fit.**

Additional Rules: Please complete, sign and return this Registration Form and the included Consent, Waiver and Release of Liability Form (located on the backside of this Registration Form) with **EACH** photograph you submit for entry in the contest. Photos will not be accepted unless they are accompanied by both a completed Registration Form (this side) AND a completed Consent, Waiver and Release of Liability Form (reverse side). Each entry will be subject to the rules set out in this entry form. Each entrant is **LIMITED** to the submission of four photos. Please note that only still photographs will be accepted. Videos will not be accepted. Also, photos that include people (adults or children) will not be accepted.

Judging: Once received, the photos will be assigned a number identification and submitted without names associated to the photos to the 3-member ODHFB photo contest committee who will serve as judges of the contest. Winner/s will be notified no later than September 10, 2015.

If submitting photos to the contest, please accompany **EACH** with both sides of this form completed (front...Registration Form and back...Consent, Waiver and Release Form).
