- Gus Jasminski, Applicant, addressed the Board and presented an overview of the proposed sign, noting that the sign is not visible to neighboring properties or from public roads. It is only visible on the property itself.

 - Mr. McGregor noted the sign regulations do not allow the panels or the box to be lit internally.
