b. Chief's Report

Chief Ingvertsen reported the following:

- The CALEA on-site was performed March 20th through the 22nd. The on-site went very well and the Department expects to be recommended for reaccreditation.

- Budget discussions are nearly complete and will be finalized at the referendum on June 13, 2017.
