The Town Manager has indicated that the request for the second in command position is a top priority for her in this budget cycle.

- At the Special Olympic 2019 Torch Run kick off meeting, the department received 2 awards for raising over \$15,000 in 2018.

Commissioner Long put in a request to the Board of Selectmen to table the private duty rate change proposal for the Simsbury Performance Arts Center at tonight's meeting. The Commission would like to review the details.
