### **SENIOR CENTER REPORT**

Kathleen Marschall, Senior Center Coordinator, noted the only elevator in Eno Hall is still out of service while being replaced. Service began February 20th and will likely continue until early

- ➤ Picnic at the Farms July 20<sup>th</sup> at Simsbury Farms Ice Rink, 6-8pm. Margaret Haldeman is working with Kathy Marschall on logistics, funding, entertainment.
  - Musician Dan Reisert and magician Paul Kilmer are confirmed for the picnic.
    Libby Easton-May suggested asking them to discount their fees.
  - o Kathy Marschall noted that we do have \$1000 budgeted for the picnic.
  - Contact has been made with library, Best Buddies and Unified Theatre at the High School, and with the Y for help with activities at the picnic
  - Pure Love has committed to 80 cupcakes (gluten-free)
  - With respect to food and financial assistance, requests have been made at Big Y, Geisler's, Stop & Shop, Antonio's, The Lions Club and the Jr Women's Club. Follow-up is needed.
  - Plan to ask First Church for funding

- Souper Thursday, May 9<sup>th</sup>
  - Ed LaMontagne announced a \$1000 donation from Simsbury/Granby Rotary to fund the Souper Thursday events.
  - Cheryl Cook reported that Antonio's has agreed to provide a sandwich, soup and dessert for 60 at \$8/person, delivered.
    - Asking about flatware, etc.
    - RSVPs from attendees expected about a week prior
  - O Volunteers needed. Ed will ask Rotarians.
  - Ed noted that Terry Henault and Deb Glass may be able to contact Antonio's about menu specifics.
  - Typical number of participants 40-60/lunch

  - Jen Seiderer posed a question about updates. Updates will be managed quarterly. Corrections will be handled ASAP. Jen is now working on how best to produce a hard copy of this largely digital material for use at the library.
- Affordable Housing Update
  - Cheryl Cook reported on the progress in creating the Housing Advisory
    Committee comprised of members of relevant existing commissions
    - Jen Seiderer is the A&D representative and Jan Beatty is the alternate
  - Cheryl Cook (Chair of the Simsbury Housing Authority Board of Commissioners) noted that the Simsbury Housing Authority (SHA) is not represented on the towns Housing Advisory Committee.
  - Cheryl shared that she and several others helped State Rep. Osborne apply for a federal grant to benefit the SHA (application was prepared and submitted in 5 hours). The application was approved for \$640K. Additional information will be needed and will be managed by Christine Winters (Exec. Dir. of Simsbury Housing Authority)
  - Cheryl also reported that the Vessel properties project has been approved for three stories along with other design changes

- including up to 8 affordable units
- o Discussion also included the fate of the Hartford property
- Zoning Bd to change Inclusive Housing as part of their deliberations
  - Comments on Missing Middle- between single family home and high density and Pathway to Ownership
  - Comment from Mike Jennings about the segment that doesn't want to own (transitional)
  - Comment from Jan Beatty about AARP asset about "Middle Housing"
