WATER POLLUTION CONTROL AUTHORITY REGULAR MEETING May 14, 2009

I. CALL TO ORDER

Chairman Philip Richardson called the regular meeting of the Water Pollution Control Authority to order at 7:30 p.m. at the Simsbury Water Pollution Control Facility Conference Room, 36 Drake Hill Road, Simsbury. II. DRAFT MODIFICATIONS OF SEWER USE ORDINANCE

Editorial comments received to date were reviewed. A final draft incorporating all changes will be prepared and presented for review by Town Counsel.

III. DRAFT MODIFICATIONS TO PERMIT AGREEMENT FOR PRIVATE SEWERS BY DEVELOPERS

Chairman Richardson asked members to review the text, with comments and revisions to be discussed at the June meeting.
