WATER POLLUTION CONTROL AUTHORITY REGULAR MEETING OCTOBER 8, 2009

I. CALL TO ORDER

Chairman Philip Richardson called the regular meeting of the Water Pollution Control Authority to order at 7:32 p.m. at the Simsbury Water Pollution Control Facility Conference Room, 36 Drake Hill Road, Simsbury, CT. The following members were present: Warren Coe, Gary Faraci, Ed Kelly, and Michael Park. Also present were: James Clifton, Superintendent WPCF; Kendra Dahlquist, Clerk; Richard Sawitzke, Town Engineer, and other interested parties. Philip Burton and Paul Gilmore were absent.

II. PUBLIC HEARING: WOLCOTT ROAD ASSESSMENTS

Mr. Richardson opened the public hearing by reading the Legal Notice, as follows:

Copies of the proposed assessments are on file at the Simsbury Town Clerk's office. This will be the one and only hearing of the Authority on these assessments. Any affected property owner may appear and be heard.

Mr. Richardson immediately reconvened the regular meeting and Mr. Kelly moved and Mr. Coe seconded a motion to approve the assessments of \$21,153.35 each, for the properties at 77, 80, 85 and 90 Wolcott Road and the allocation of \$4,166.66 for possible future extensions. Motion passed.

Bushy Hill Road @ Sidney Way: complete, with acceptance letter pending

Pheasant Lane: hearing scheduled for November

Mr. Sawitzke noted there is no longer a backlog of pending sewer projects, but there are a number of approved projects in town.

V. WATER TREATMENT FACILITY REPORT

Mr. Clifton noted he had begun budget preparation for spring completion, and that the rehab of south Pump Station is relatively complete. Details of permit compliance data have not yet been received from the laboratory, so that information will be forwarded to the Authority by email when it is

available.
