Public Audience: Pat Cowles and Victoria Garden Eden both of Simsbury.

Pat Cowles stated that she feels there is a need for senior housing in the center of town so residents who do not drive would have access to many facilities. She stated that the current housing is not convenient to center facilities/stores. She also stated that this should be the town's first priority versus a new senior center.

Victoria has a senior support business. She posed several questions about the legality of building accessibility both public and private.

Invited Guest: Lieutenant Sifodaskalakis, Operational Commander for the Town of Simsbury Police Department.

The Board of Selectman has designated the month of June as Handicapped Parking Awareness Month in the Town of Simsbury. The Commission had asked a representative from the police department to attend tonight commission meeting to discuss what steps would be taken to increase handicapped parking during the month of June. Lt. Sifodaskalakis stated that the police have done almost 2000 sweeps this past year and will continue to do so during the month of June. The commission will take the responsibility for publicity and awareness. Several options were discussed for publicity and enforcement.
