At their meeting on May 3, 2021 the Hometown Hero Selection Committee agreed by consensus to establish a regular meeting schedule for 2019 as follows:

Monday, May 2, 2022 at 6pm

The meetings will be held virtually or in a location to be determined. Meetings will be properly noticed in accordance with FOIA requirements.

Guidelines for the Hometown Hero Program

Adopted by Board of Selectmen November 13, 1996 Amended February 23, 1998

Amended March 26, 2018

1. Background Information

The Program was initiated in 1986 by Governor William O'Neill as part of the 350th Anniversary of the founding of Connecticut. Any municipality could designate residents as "Hometown Heroes" for any deed or service that made the community a better place in which to live. State certificates were presented to the 42 individuals and 4 organizations on May 12, 1986. The following year, First Selectwoman Margaret Shanks continued the program with certificates developed for Simsbury, naming 48 designates. It has been continued since, with Hometown Heroes recognized at a ceremony during the month of May as May 12th is the date of Simsbury's birth.

2. Criteria for Selection

- A. A person(s) who is a resident, or who is active in the Simsbury community, or who lived in Simsbury during the time period that is under consideration.
- B. Person(s) who has demonstrated selfless and altruistic behavior which contributes significantly to the betterment of our Town.
- C. That such deed or action performed inures primarily to the Town of Simsbury, although not necessarily exclusively; and that.
- D. Any individual or group that has been nominated to the Hometown Hero Award Committee (henceforth "Committee") shall be duly considered with the following exceptions:

The hero shall not be a member of Town staff, nor a sitting elected or appointed official. Nor shall the hero have benefited economically from his/her endeavors on behalf of the Town.

E. There will be no quotas or automatic selections by the Committee. Recognizing the premise that an abundance of awards will dilute the significance of the award, the Committee is duly charged to use its discretion in the number to be awarded.

3. The Selection Process

- A. Written nominations will be requested and received during a thirty (30) day period typically occurring in whole or part during the months of March and/or April.
- B. The Selection Committee shall review the names nominated for the Hometown Hero Award. The Committee shall make selection and approve the list of award recipients no later than two weeks prior to the scheduled ceremony.
- C. The Town Manager's Office shall notify all award recipients of the time and place of the award ceremony.
- D. The Town Manager's Office shall complete arrangements for the ceremony such as scheduling, publicity, and refreshments.
- E. The names of award recipients will be engraved on the Hometown Heroes plaque displayed in Town Hall.

4. The Selection Committee

The Selection Committee shall be appointed by the Board of Selectmen on a biennial basis. The Selection Committee shall consist of the First Selectman, a Board of Selectmen member of the opposite party, a member of the Historical Society, a business leader, a previous hometown hero, and a member of a veterans or service organization, with the goal of non-partisanship in mind.

The membership of the Committee shall be recommended by the First Selectman and the Town Manager to the Board of Selectmen. The Board of Selectmen is the appointing authority.

Staff assistance to the Selection Committee shall include reasonable requests deemed necessary by the Committee.

Jan is an active participant in town activities through her association with the Old Drake Hill Flower Bridge and the Simsbury Garden Club. Jan is an excellent team worker. She benefits the town. Jan speaks from her heart. She always pitches in.

Over many years Jan has been a volunteer at the Old Drake Hill Flower Bridge. Jan is the Secretary for ODHFB. The bridge began with four flower boxes. Now, Jan is currently in charge of the volunteers who take care of the 72 flower boxes; 32 flower baskets; 14 border column flower baskets; and the Irrigation System. This is a huge increase from the four boxes that adorned the ODHFB.

Jan prepares a diagram for each flower box, flower basket, and border column flower basket. She oversees ordering plants. Jan and the ODHFB members plant the hanging flower baskets at Pickin' Patch. Jan and others water these hanging baskets until the weather becomes warmer around the 15th of May. ODHFB members volunteer to pick up the hanging baskets and drive them to the ODHFB. Upon arrival at the Bridge the baskets get hung. The flower boxes and border column flower baskets are then to be filled with dirt and the diagram lists the proper plants to be put in place. Jan is there for supervision of all the plants and people. Fall comes and Jan oversees the taking down of the hanging baskets, and the removal of the plants and dirt; removal of the flowers from the boxes and border column baskets. Jan and crew then place evergreens in the boxes for winter.

Jan has participated with the opening of and plantings at the new Hop Brook Park.

Bob Kane has been a fixture in Simsbury for most of his adult life serving first at Fitzgeralds and then in the capacity of owner for Kane's Market. As a testament to his character, his mentor, boss and friend, Jack Fitzgerald helped him start his business despite the likely competition. Over the past 40 years, Bob has tirelessly served our community. There are many thoughts that come to mind ...

- always ready to help EVERY charity that approached him.
- He was a long-standing vital supporter of the crew team, Simsbury Volunteer Fire Dept., Boy Scouts, Girl Scouts, Simsbury, St. Mary's Carnival, Central School Carnival, Chamber of Commerce, All the schools actually... just to name a few.
- Simsbury Meadows depended on his stand for delicious food along with most other functions that needed an anchor restaurant. That probably wasn't always in Bob's best interest, but he was always there.
- Bob would always greet you by name which he learned almost immediately along with your preferences, kids' names and the last thing you bought to cook.. "How did it come out?"
- The many teenagers he mentored along with the way they would always talk about what they learned and how hard Bob worked... expecting the same! It takes effort to mentor young people in their first job and this alone was an amazing strength of his.
- Every holiday was an all out effort to meet your needs, even last minute. If you were looking for something special, he would order it or go into the back and carve it up just for you. Very few businesses would take that time.
- As a home care nurse, I would see the extra effort he would make to assist our seniors with their purchases. Many of his delicious prepared foods helped our seniors survive!
- During COVID, he was always careful in his attention to cleanliness. Everyone wore their masks. If you were buying for the freezer, he went the extra mile to shrink wrap your purchase at no charge.

In summary, the retirement of Bob is very well deserved, but he will be missed and I feel he embodies what a Home Town Hero should strive to be. I sincerely hope you will agree with me!.
