TOWN OF SIMSBURY - BOARD OF SELECTMEN REGULAR MEETING MINUTES
JANUARY 23, 2012

CALL TO ORDER

The Regular Meeting of the Board of Selectmen was called to order at 7:25 p.m. in the Main Meeting Room of the Simsbury Town Offices. Present were: First Selectman Mary Glassman; Board members Nancy Haase, Moira Wertheimer, John Hampton, Lisa Heavner and Sean Askham. Others in attendance included Chief Ingvertsen, Tom Cooke and other interested parties.

PRESENTATION

Installation of Drug Lock Box in Police Department - Chief Peter Ingvertsen

Chief Ingvertsen announced a new initiative that they have been working on for several years.

He announced that there will be a drug drop box located by the elevator. The box is on the way and should hopefully be available by the middle of February. The Town had to present to the State and Federal government so they could see how this box would be handled.

The Drug Lock Box needs to be under 24 hour camera security. Two people must take the drugs out and they are sealed and verified. They will then be stored under lock and key and alarmed before sending to be burned.

Chief Ingvertsen said the funds for this project come from the drug asset forfeiture fund, from an arrest several years ago. Therefore, there is no cost to the tax payers.

Ms. Glassman said this will be of great service to the community and thanked the Chief for his efforts.

PUBLIC AUDIENCE

Robert Kalechman, 971 Hopmeadow Street said he was at the meeting between

the Performing Arts Center Board and Board of Selectmen. He said he is reading the Kane Mutiny and he read a few lines from it.

Mr. Kalechman feels the Town shouldn't dip into reserves for the PAC Board as they always say they will stay even in their budget, but always go over budget. He feels the taxes shouldn't go up because the PAC Board doesn't work properly.

Sue Bednarcyk, 119 E. Weatogue said she also sat in on the PAC Board meeting. She feels they should hold off on paying the manager until we find out how to do things. Shouldn't double pay on one thing.

Ms. Bednarcyk spoke again about land use. She feels a master plan is needed for a whole piece not little pieces at a time. She feels electric vehicle charging stations should be looked in to not another gas station. She feels a visionary master plan is needed for the Town. Ms. Glassman told Ms. Bednarcyk she should also be speaking to the Zoning Commission.

Jeff Tindall, 47 Owens Brook Blvd. thanked the Town of the med box as he feels it will be a great benefit to everyone. He said, as Chairman of the Democratic Town Committee, they might consider combining Clean Energy and Recycling together for better efficiency.

Robert Hensley, 21 Cedar Hill Road said that the discussion at the PAC Board meeting wasn't asking for funding for their expenses, they have funds for their budget. They do want to be cash flow positive. The funding is about the consultant. There was a RFP sent out and they need help planning for the future of this incredible facility.

FIRST SELECTMAN'S REPORT

Ms. Glassman said there was a great Martin Luther King Day Ceremony last Monday. The High School students have been working hard to raise funds to erect a statute to honor Dr. King and Cigna has now donated \$20,000.

Ms. Glassman said there were two events that focused on steps that can be taken to better prepare for an emergency. The Public Safety Committee is working very hard and specific initiatives have been identified and will be implemented.

Ms. Glassman thanked the Public Safety Committee, employees, and dedicated public servants and residents for helping with this process.

Ms. Glassman said the Department Heads have submitted their budgets to the

Director of Finance. The Town staff is taking the opportunity to do some goal-setting as part of the budget process. As budget information becomes available, it will be posted on the Town's website budget page.

Ms. Glassman said CL&P informed residents that it is resuming work on the repair of Town's electric transmission structure. This work will hopefully be completed by late March 2012.
