Repairs and Improvements to Orkil Pond Dam
Simsbury, Connecticut**

Sealed bids endorsed "Repairs and Improvements to Orkil Pond Dam, Simsbury, Connecticut" will be received at the office of the Finance Department, 933 Hopmeadow St., Simsbury, Connecticut until Tuesday, September 27, 2022, at 2:00 p.m. (EST) at which time they will be opened in public by the Director of Finance. Bids received after the time set for the opening may be rejected.

This project includes grading of the existing earthen-embankment dam slope, raising the earthen spillway crest, widening the earthen auxiliary spillway, the existing drop-inlet type spillway in 54-inch stand-pipe will be replaced with a cast-in-place box structure with an associated carp screen and slide gate, the existing 54-inch corrugated metal outlet pipe will be replaced with a 60-inch diameter reinforced concrete outlet pipe, and replacement of the existing rounded stone with standard rip rap is also proposed

A non-mandatory Pre-Bid Site Visit will be held at the project site on September 13, 2022 at 11:00 a.m. local time. All attendees for the pre-bid meeting will meet in the parking lot of the Simsbury Parks and Recreation Maintenance Department which is located at 76-80 Hop Brook Road behind the red barn and the group will be led to Orkil Pond Dam via vehicle.
