A special meeting of the Housing Authority of the Town of Simsbury, Connecticut was held on April 27, 2018 at the Virginia Connolly Residence, 1600 Hopmeadow St., Simsbury, Connecticut. DISCUSS AND APPROVE FY 2018-19 BUDGET

Mr. LaMontagne provided an update of the FY 2017-18 budget including projected income and expenses for the remainder of the fiscal year. Mr. LaMontagne then reviewed the proposed FY 2018-19 budget. This budget represents a 5% increase. After discussion, Commissioner Fleet made a motion to approve the FY 2018-19 budget. The motion was seconded by Commissioner Cook and all members voted in favor. The budget will now be sent to the State Department of Housing and CHFA for approval.

DISCUSS AND POSSIBLY APPROVE NON-RECURRING EXPENDITURES

Mr. LaMontagne presented Capital Non-Recurring projects for FY 18-19. He stated that some of the projects were identified in the 2014 Capital Needs Assessment Report. In addition, CHFA requires properties to spend down a portion of their reserves before they can apply for critical needs funding from CHFA.
