MINUTES OF THE PREVIOUS MEETING

EXECUTIVE DIRECTOR'S REPORT

1. FY 18-19 Audit

Auditors from Roy and Associates were on site October 24th and 25th to perform the FY 18-19 audit. The draft audit should be ready in approximately two weeks.

2. 2020 Small Cities Grant

The town plans on posting the RFP for a qualified consultant on to the DAS website and Town website on Monday, November 4th. The town will also arrange to have the RFP printed in the Hartford Courant. Per my request the town will also mail the RFP to those firms that responded to last year's RFP. The town will collect the responses and set up interview dates for early December.

3. Apartment Inspections

The apartment inspections for the Dr. Owen L. Murphy Apartments have been completed. Reports are currently being compiled after which letters will be written to those residents not in compliance with their lease. Apartment inspections for the Virginia Connolly Residence will be completed by the end of the year.

4. Marketing

The Housing Authority had a booth at the Chamber Chili Fest on October 20th.
 Approximately 3,000 people attended. Comments from people who stopped by the booth included not knowing there was a Housing Authority in Simsbury and the lack of affordable housing in Simsbury. Information and pens were distributed as well as about three pounds of candy to children who were trick or treating.

RESIDENT VACANCY STATUS

As of the end of October there were three vacancies at the Dr. Owen L. Murphy Apartments with seven individuals on the waiting list. There are three vacancies at the Virginia Connolly Residence with five individuals on the waiting list and one person expected to move in in November.

OLD BUSINESS

1. 2020 Small Cities Grant

The Housing Authority will need to acquire an architect for the proposed projects, however it was stated that a consultant needs to be hired prior to contracting with an architect. If a consultant is obtained in December then an architect would be contracted in January. It was noted that the expense for an architect would come out of the HA's operational fund and not be reimbursed by the small cities grant.

2. Action Items Update:
