1. CALL TO ORDER

b. Chief's Report

Chief Ingvertsen reported the following:

• The Chief provided the Commission with an update on the condition of the Officers who are or were out of work or on modified duty.

• The Chief provided the Commission with an update of the CALEA Accreditation process and the upcoming Mock Onsite Review on February 1, 2011.

• On January 8, 2011 the department held a "Drug Take Back," along with the Avon and Canton Police departments in the Simsbury Commons parking lot. The program was a tremendous success and the department hopes to hold the event again in the future.

• An update on the Certified Officer and Dispatcher recruitment process was provided by the Chief.

c. Consolidated Monthly Report for November (Addendum 3)

Commissioner Cosgrove questioned whether the bear calls were lower than last year. Lieutenant Boulter indicated that they were down and that this was primarily due to residents becoming better educated and more accustomed to having the animals in the area.

Commissioner Walsh inquired about the nature of the injuries that have been

sustained by officers. The Chief responded that they were a combination of shoulder, knee, neck and back injuries that occurred both on and off the job.

Commissioner Goodfriend commended the C Squad officers for their work enforcing DUI's.
