## 4. Legislative Updates

Mattress recycling (SB 89)

Connecticut disposes of 300-400,000 mattresses annually, at cost to the towns over \$1 million. The Mattress bill would require manufacturers to create a system to capture these mattresses and send them for component recycling, legal remanufacture, or other appropriate post-consumer disposal, Paid for by the manufacturers with costs ultimately borne by consumers instead of taxpayers, government, and society as a whole. Connecticut has in recent years implemented Extended Producer Responsibility (Product Stewardship) programs for electronic waste and unused paint. This program would operate in a similar fashion. As there would be no cost to dispose of a mattress, illegal dumping should be greatly reduced.

Safe Pharmaceutical Disposal (SB 92)

Protect the environment and improve public health and safety by implementing a safe pharmaceutical disposal program where State Police will be expected to house lockboxes for the anonymous disposal of unused and expired pharmaceutical drugs. Pharmacies throughout the state will also be required to provide educational materials to their customers, informing

them of the law and providing them with information about where they can dispose of their drugs. This will protect our environment by eliminating countless drugs, antibiotics, and hormones from ending up in our waterways and our ground water, while increasing public safety by providing the public with a safe, accessible place to dispose of their medications.

#### Mercury Thermometer Recycling (SB 93)

Mercury is highly neurotoxic to all of us and exposure to even a small amount can cause learning disorders and developmental delays in young children, and a single gram is enough to make all of the fish in a 20 acre lake unsafe to eat for a year. Connecticut was the first state in the U.S. to ban the sale of mercury thermostats, but we have never required manufacturers of mercury thermostats to take responsibility for the safe collection and proper recycling of the estimated 1.7 million mercury thermostats still in use in homes throughout the state. These thermostats go into our landfills and incinerators, releasing toxic mercury into our air and water. The proposed bill would require manufacturers of mercury thermostats to meet performance goals for collection of end-of-life mercury thermostats and pay minimum \$5 incentive to anyone returning a mercury thermostat to a recycling center. This approach has proved successful in other states and pilot programs.

#### 5. Recycling Education Campaign

A. Lori met with Jim Goodwin at Simsbury Farm who informed her they donated 4,000 pounds of produce to food banks. There also is a staff member who runs a number of camp programs. On Wednesday, May 30 at 7pm an environmental educator who is to hold a program on gardening. The farm is interested in hosting a composting program. The farm wants to talk about the farm. Mary suggested she meet with the staff prior to the composting program to see if she could be of any assistance.
