
3) Next steps

Summary

Pursuant to <u>Section 615</u> of the Simsbury Town Charter the Town will have an Open Space Committee. This committee's purpose is to assist and advise the Board of Selectmen in identifying and evaluating land deemed suitable for acquisition and preservation, and in administering the fund for land acquisition and preservation. Membership of the Open Space Committee consists of the First Selectman or First Selectwoman, Chair of the Planning Commission, Chair of the Conservation Commission, Chair of the Zoning Commission, Chair of the Culture, Parks and Recreation Commission, or their designees, and three (3) other members to be appointed by the Board of Selectmen.
