
Following a large tree falling and uprooting there is slope failure threatening the stability of Riverside Road. Corrective work includes placing riprap in the void space (less than 50 cy), placing processed gravel on the slope for stabilization (less than 50 cy) and possibly placing top soil over the are to allow for vegetation to stabilize the slope.
