Installation of (1) 275 Gallon Outdoor Above Ground ROTH Double Wall Safety Oil Tank On a New Pre-Cast Concrete Slab. The crew will dig down approximately 4-6" to lay processed stone. The slab dimensions are 40 x 60 x 4. The tank will be located on the rear left corner of the house. Approximately 95' from the wetlands area on the property. Erosion control techniques will be used. Work to be completed in 1 business day time.

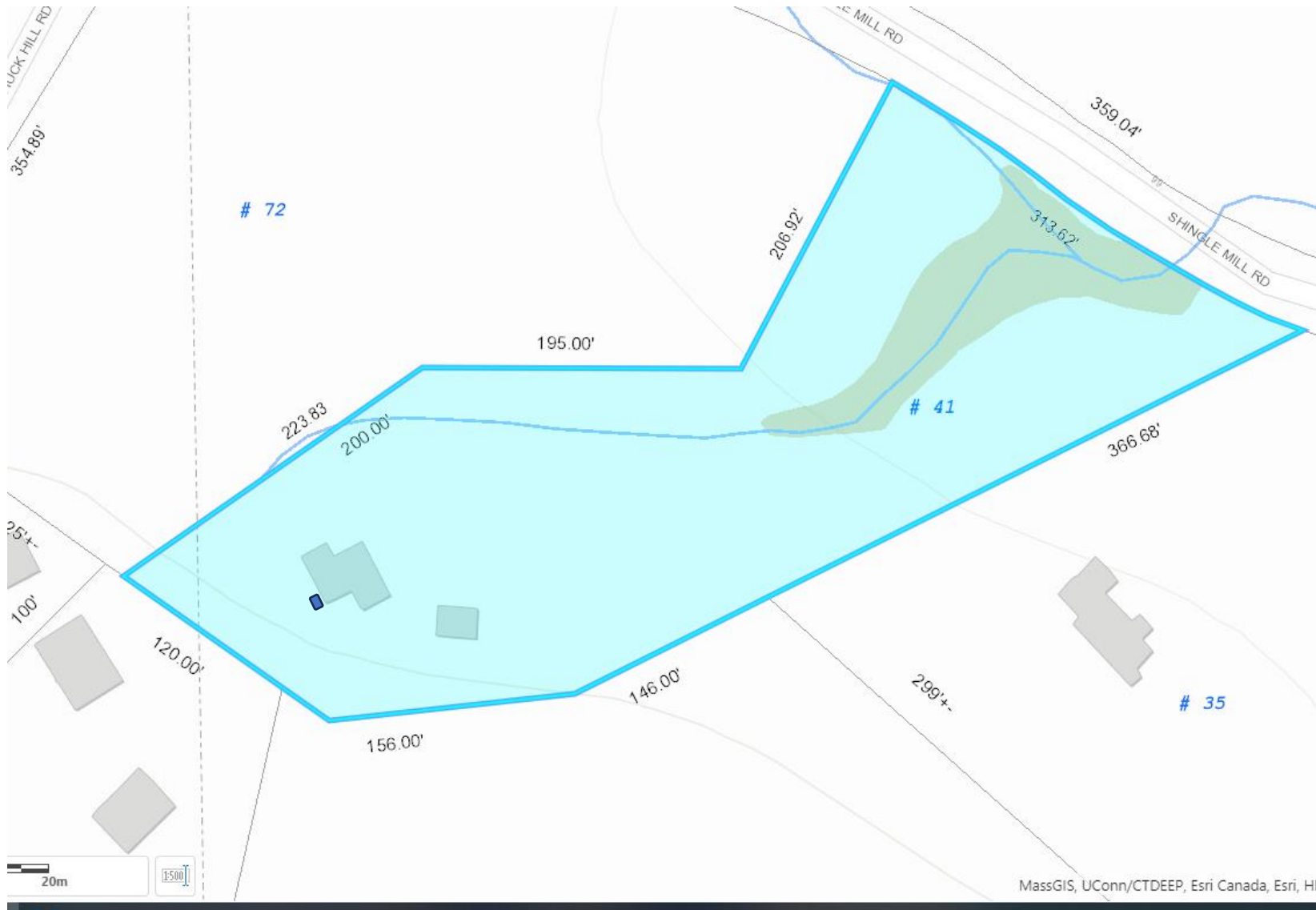

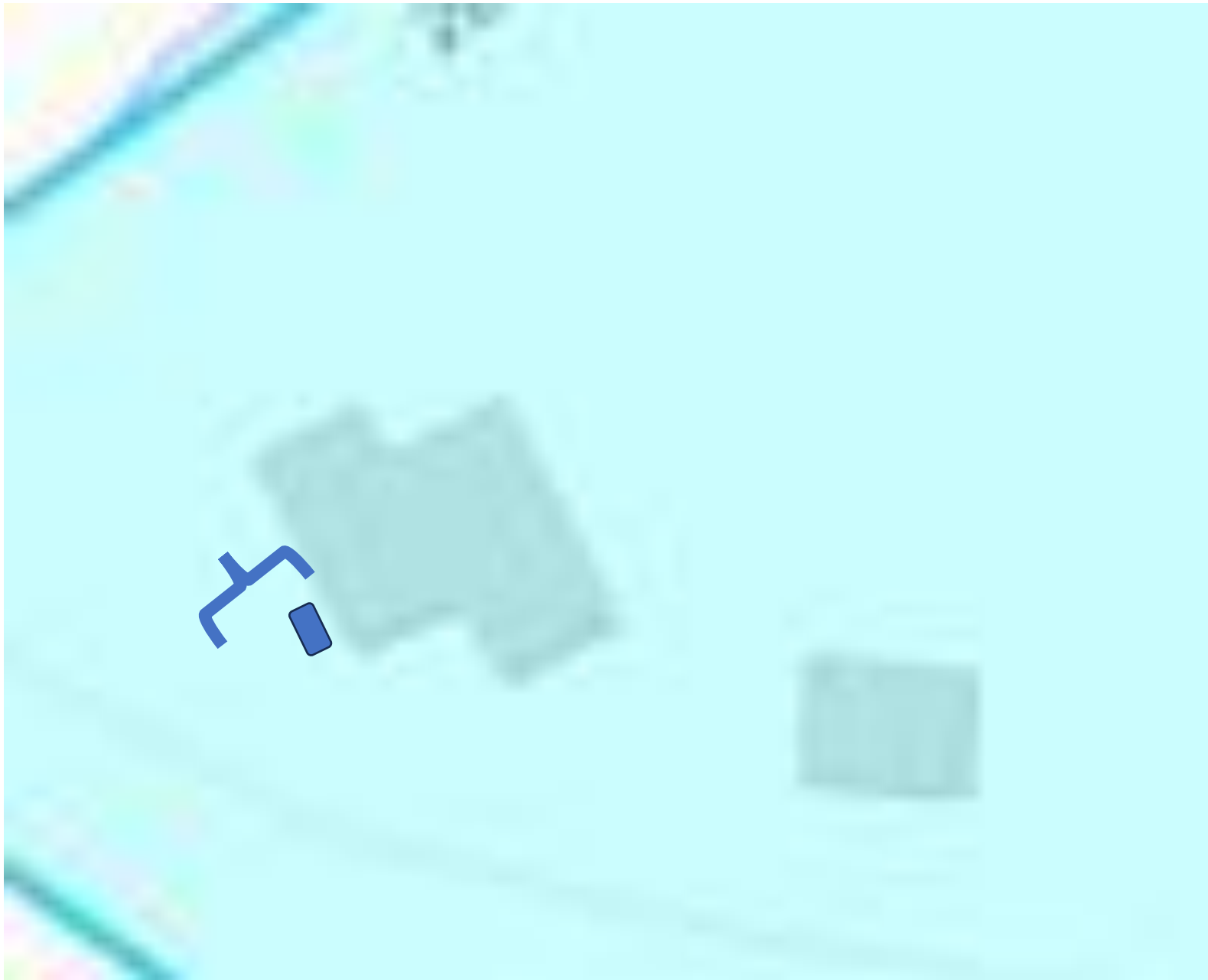
