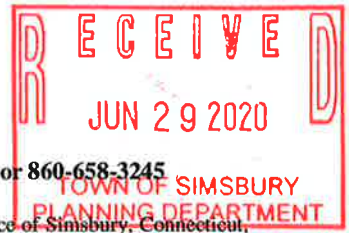

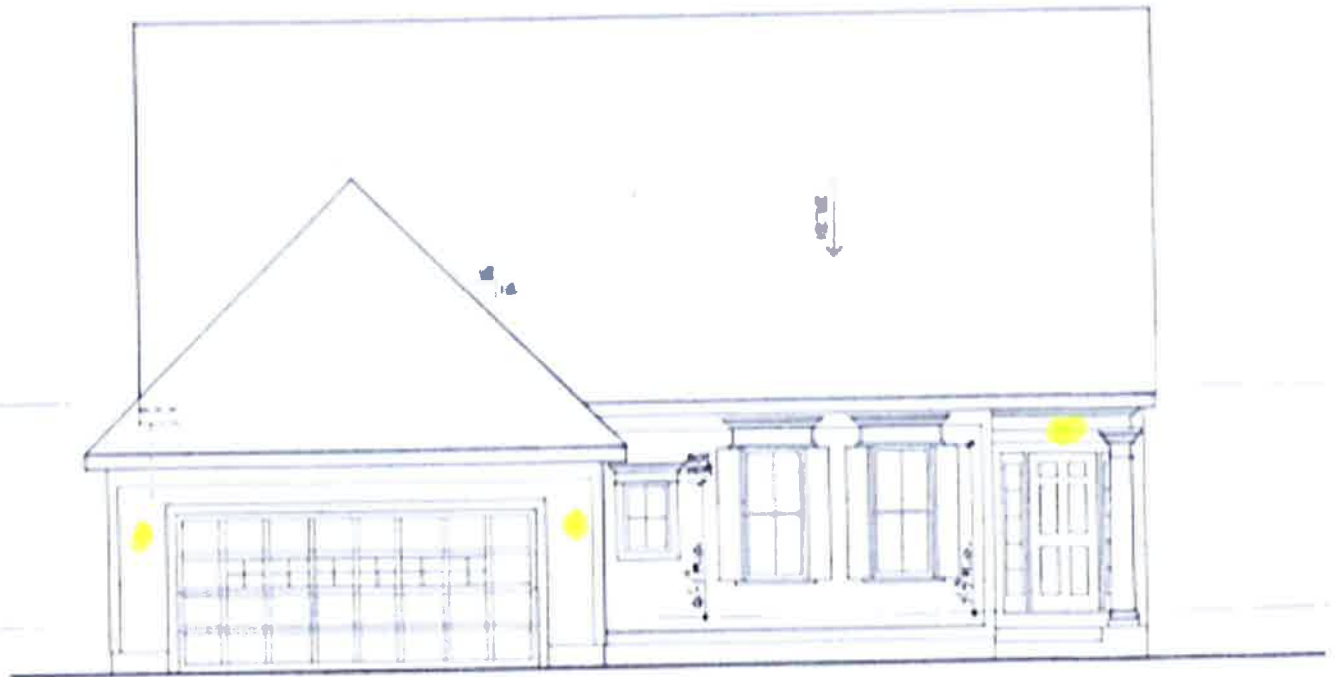

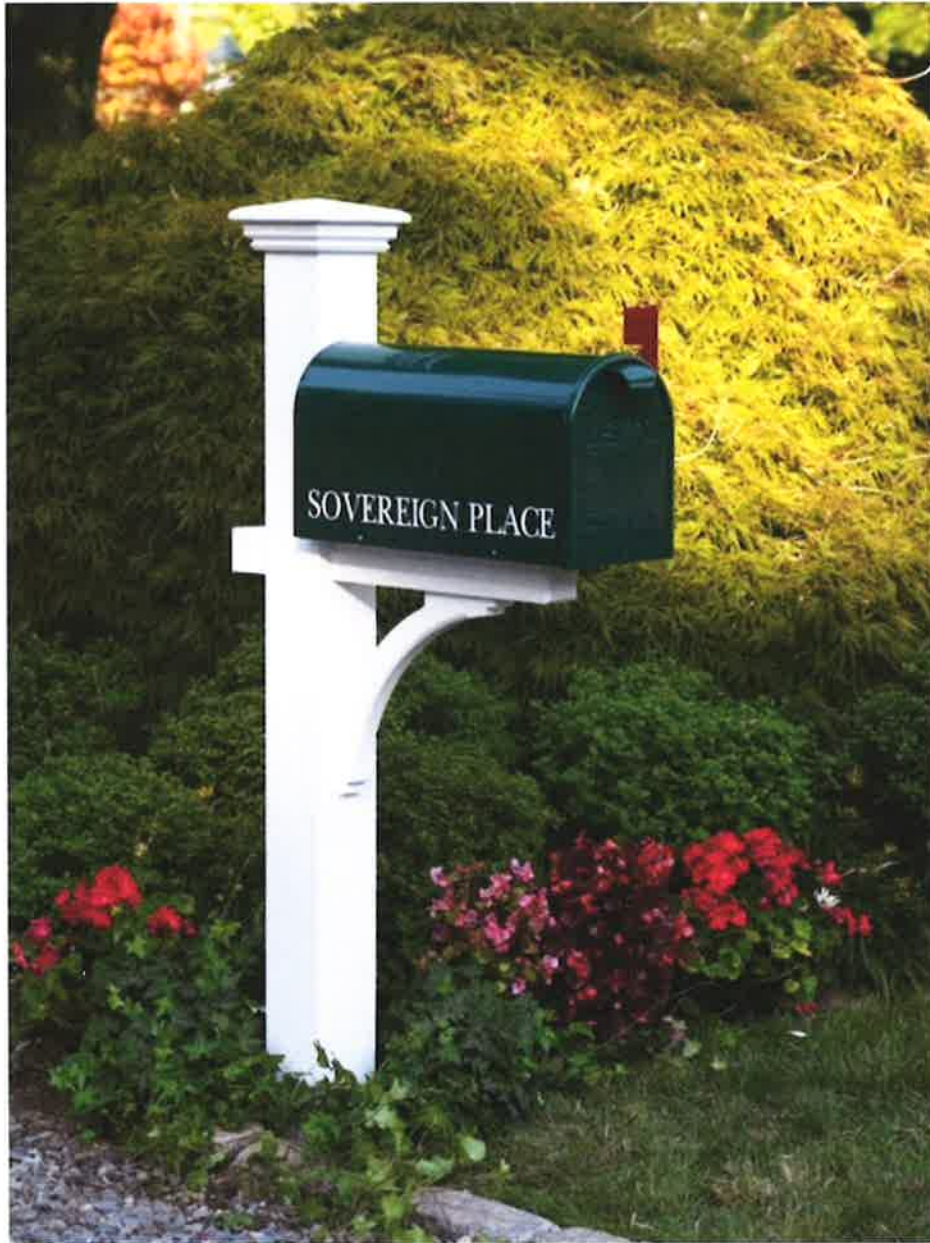
● Exterior Lighting Placement
