Map G10, Block 227, Lot 001+2), Simsbury, CT 06070, Zone SC.

Summary of Request

710 Hopmeadow Street is within the Center Zone (SC) and is the location of two buildings, Drake

Hill Mall, which is a commercial shopping plaza (CVS, Fitzgerald's) and the Canon Building, an office building.

The Applicant proposes to resubdivide the 5.15-acre property into two, creating a smaller lot approximately 27,127 s.f. as shown on the picture to the right. The applicant states that the proposed re-subdivision is being requested for ownership/financing purposes.

There was a previously approved subdivision for the lot a number of years ago and therefore, any additional lots created require the resubdivision public hearing process.

Staff Review

requirements of the Town's Subdivision Regulations. In addition to compliance with those regulations, the lots must also conform to the zoning requirements for the zone in which it is located, which is the SC (Center Zone). Staff reviewed the two lots to ensure compliance and they generally are with two exceptions- two bike spaces are required to be installed on the Canon Building lot and as such, the applicant has added this element to the site plan. Also, a cross-easement is required to grant access between the adjacent parcels for parking, pedestrian travel and other uses. With these minor additions, the plan meets the zoning requirements for the Simsbury Center Code and thus, staff has no objections to the re-subdivision application.
