> As a mother of three school aged children in Simsbury who has lived here for over 20 years, I am not in support of retail cannabis being sold in our town. It does not align with the culture and characteristics of the town and, certainly, does not align with the values I am instilling in my children. I do not want easier/closer access to cannabis, by our children, our residents and, frankly, by all of the other people coming into Simsbury from surrounding towns and states, by being the first town in the state to allow retail sales.

> An argument for allowing retail sales is based on the financials, which in and of itself is not very compelling, but, in order to fairly evaluate that argument, I would like to see accurate and complete data regarding the financial benefits (and expenses incurred) that Simsbury will obtain from being the first in the state. I would like such data provided to the residents so we can evaluate the validity of such argument.

> Finally, I have seen examples of how poor commercial development decisions (based on limited or inaccurate facts regarding possible benefits) can negatively impact the culture and characteristics of a town. Simsbury has done a great job preserving its unique and desirable character and I would hate to see a poorly, uninformed decision begin to deteriorate the positives of this town. As has been demonstrated in multiple towns in the state, an initial poor commercial decision begets further poor commercial decision - it is a slippery slope that is difficult to stop

and/or reverse.
