At their meeting on May 2, 2022 the Hometown Hero Selection Committee agreed by consensus to establish a regular meeting schedule for 2023 as follows:

Monday, May 1, 2023 at 6pm

The meetings will be held virtually or in a location to be determined. Meetings will be properly noticed in accordance with FOIA requirements.

Guidelines for the Hometown Hero Program

Adopted by Board of Selectmen November 13, 1996 Amended February 23, 1998

Amended March 26, 2018

1. Background Information

The Program was initiated in 1986 by Governor William O'Neill as part of the 350th Anniversary of the founding of Connecticut. Any municipality could designate residents as "Hometown Heroes" for any deed or service that made the community a better place in which to live. State certificates were presented to the 42 individuals and 4 organizations on May 12, 1986. The following year, First Selectwoman Margaret Shanks continued the program with certificates developed for Simsbury, naming 48 designates. It has been continued since, with Hometown Heroes recognized at a ceremony during the month of May as May 12th is the date of Simsbury's birth.

2. Criteria for Selection

- A. A person(s) who is a resident, or who is active in the Simsbury community, or who lived in Simsbury during the time period that is under consideration.
- B. Person(s) who has demonstrated selfless and altruistic behavior which contributes significantly to the betterment of our Town.
- C. That such deed or action performed inures primarily to the Town of Simsbury, although not necessarily exclusively; and that.
- D. Any individual or group that has been nominated to the Hometown Hero Award Committee (henceforth "Committee") shall be duly considered with the following exceptions:

The hero shall not be a member of Town staff, nor a sitting elected or appointed official. Nor shall the hero have benefited economically from his/her endeavors on behalf of the Town.

E. There will be no quotas or automatic selections by the Committee. Recognizing the premise that an abundance of awards will dilute the significance of the award, the Committee is duly charged to use its discretion in the number to be awarded.

3. The Selection Process

- A. Written nominations will be requested and received during a thirty (30) day period typically occurring in whole or part during the months of March and/or April.
- B. The Selection Committee shall review the names nominated for the Hometown Hero Award. The Committee shall make selection and approve the list of award recipients no later than two weeks prior to the scheduled ceremony.
- C. The Town Manager's Office shall notify all award recipients of the time and place of the award ceremony.
- D. The Town Manager's Office shall complete arrangements for the ceremony such as scheduling, publicity, and refreshments.
- E. The names of award recipients will be engraved on the Hometown Heroes plaque displayed in Town Hall.

4. The Selection Committee

The Selection Committee shall be appointed by the Board of Selectmen on a biennial basis. The Selection Committee shall consist of the First Selectman, a Board of Selectmen member of the opposite party, a member of the Historical Society, a business leader, a previous hometown hero, and a member of a veterans or service organization, with the goal of non-partisanship in mind.

The membership of the Committee shall be recommended by the First Selectman and the Town Manager to the Board of Selectmen. The Board of Selectmen is the appointing authority.

Staff assistance to the Selection Committee shall include reasonable requests deemed necessary by the Committee.

I would like to take this opportunity to nominate, Marianne B. O'Neil, for selection as a Simsbury Hometown Hero.





GERRY WETJEN

Gerry Wetjen moved to Simsbury in 1978. He began his volunteer activities immediately after he unpacked.

He has been a volunteer in a variety of organizations starting with youth sports. He was very active with Simsbury Youth Hockey. He held every leadership position with that organization over his 8 year tenure on the Board of Directors. He also has been a baseball coach with Simsbury Little League coaching at every level from T-ball through American Legion. He coached for the better part of 20 years.

He has also been a very active volunteer with the Simsbury Rotary. His involvement spans 20 years. He is particularly proud of the fact that he ran the charity golf tournament for 20 years. He also established the £d Dodd Scholarship Fund which provides approximately \$20,000 worth of scholarships per year. He was also instrumental with the Rotary's involvement in the Iron Horse Playground, where he oversaw its construction.

Gerry is an avid golfer. He has been a long time member of the Simsbury Farms Golf Men's Club. He has held every leadership position on the Board of Directors for this organization, starting in 2003 through 2010. He only left the Board to be available to engage in other volunteer activities. He was instrumental in developing and implementing the Tee-Sign sponsorship program. This program has resulted in funds being made available at no cost to the taxpayers, to pay for items at the golf course such as green collers, wood chippers, bunker rakes, flag pins and installation of drinking fountains.

In 2011, Gerry was appointed to the Cuitural, Parks & Recreation Commission. He served with the Commission for 10 years. He proved himself to be an invaluable resource to the Commission, especially with his finance background. He helped the Commission meet challenging budget issues. He participated on numerous sub-committees, including the Special Revenue Fund sub-committee in an effort to explore the best possible way to operate the golf course and manage finances.

One of the most significant volunteer activities for Gerry relates to his involvement with the non-profit group. The Friends of Simsbury Farms. In the summer of 2015, he along with two other Simsbury residents began to formulate the concept of the Friends of Simsbury Farms. They wanted to create a non-profit organization that could operate in conjunction with the town to seek donations for improvements at the Simsbury Farms Complex. The Friends of Simsbury Farms were approved by the Town of Simsbury and obtained tax exempt status in May of 2016. Since that time, there has been over \$172,000 in donations. An example of some of the improvements that have been funded by the Friends of Simsbury Farms are the Brian Koscher Pavilion located by the tennis court, a new hockey electronic scoreboard, Simsbury Farms Complex way finding/directional signs and the basketball court constructed next to the tennis court. He has continued his volunteer efforts with the Friends of Simsbury Farms, as the Simsbury Farms Complex turns 50 years old this year.

Gerry exemplifies the altruistic behavior which has contributed significantly to the betterment of the town.



Description of Nominee:

Melissa Jean Gonzalez is the owner of a local dance studio called Terpsichore. She has been a resident of Simsbury for 37 years since 1985. She opened Terpsichore in 1993. She is approaching 30 years of business serving the community. She has over 120 students enrolled ranging from 2 years to adults. Melissa has been a stable and encouraging resource for the children during the last two years of the pandemic. Melissa created a safe and fun environment where the kids could just be kids and didn't have to worry about what was going on in the world. When the world went virtual, Melissa had to quickly learn zoom and turned dance classes into fun virtual dance classes. This wasn't an easy task and something which wasn't her expertise. She hosted dance classes and activities including dance parties, games and trivia on zoom. This was during a time when the kids couldn't see their friends so she provided a fun online environment for the kids to be "together". When classes were able to resume, Melissa set up an outdoor dance camp with cohorts and bought bottles of sanitizer, cleaning supplies and implemented new health policies. She realized the seniors lost a lot in 2020 (e.g. senior prom, activities, and regular graduation) she was determined to make sure they didn't lose their last dance recital. She arranged a socially distanced dance recital outside for the kids to perform and most importantly for the seniors. It was the first time the kids had seen each other in person. It was magical for the kids to be able to see their friends in person.

In June 2020, she was told her lease was not being renewed and she had to move by July 2020.

It's not easy moving a dance studio. She had to pull up the dance floors, remove the ballet bars, remove the dance mirrors and move all of the costumes. She moved into a building in Mill Pond Lane. She had to paint each room, put the dance floor in, add the ballet bars, decorate the rooms and make it into her studio. In the fall of 2020, she continued her dance classes continuing the focus on socially distancing, health checks and extra cleaning protocols. She held an outdoor Halloween dance show for the kids to be able to perform. When she found out the high school wasn't doing an in person musical she added a musical class so the kids would have an opportunity to perform. They performed the musical 13 outside. She built a stage so she could have the shows outside, bought a mat for tap so it could be used outside and other equipment. She had the two dance recitals outside and one at Iron Horse.

In early Dec 2021, she found out that she had to move AGAIN from her dance studio. Luckily she found a place close in Mill Pond but she had to move within 3 weeks during the Holiday season. She had to do the same work as the last studio – paint each room, move the dance floor, add the ballet bars, decorate the rooms, move all of the costumes and furniture, etc. Plus, on top of moving she had a Disney trip for the dancers during the Dec – Jan break. Everyone was so excited and couldn't wait for the trip. They practiced all summer and fall to be able to dance at City walk in Universal. Approximately 50 people went on the dance trip to Disney/Universal with going to 6 parks in 7 days. It was an amazing time with lots of great memories for the kids. It was probably one of the first vacations many of them had in the last two years. It was exactly what the kids needed for their mental health.

In addition to running her studio, she did the dance choreograph the middle school production of Frozen Jr.

Melissa's tuition is very reasonable and family friendly. She has a family plan where kids and adults from the same family can take as many classes for one price. She runs her studio as very inclusive and as a family atmosphere. She has Halloween and Holiday parties for the kids. She is very inclusive and several students with special needs attend several classes. Not only is Melissa a dance teacher but she is a role model for her students, the parents and the community. She is warm and welcoming and exactly what the kids needed during such a difficult time for their mental health.

I understand she is a business owner but I guarantee she doesn't make much money because of everything she does for these kids. She has helped over 200 kids not only get through the pandemic emotionally but thrive through it. They were able to be safe, with their friends and do what they love to do - perform.

I hope you will consider her as a hometown hero after she has done so much to impact the Simsbury families for almost 30 years in the community.
