

Architectural Metal Canopy w/ Down Lighting

- See all details on this page and detail D on page 1A.2
- All materials and exposed fastener heads to be painted PMS 165C
- Downlight fixtures to be white with white illumination
- Connection point at canopy for Tie Rod Yokes to also be pick up points
- Canopy to be pre-assembled, pre-wired and UL stamped in shop
- Lag bolted into wood blocking provided by GC
- Secure diverter pan to wall with tek screws and silicone caulking sealant
- Apply a full bead of Silco RTV 4500 High Strength Silicone Sealant caulking along top of canopy; sealing it to wall

*Shims may be required behind mounting plates, at time of installation to level out with existing trim board

- Boarder to be blind stud mounted flush to backer *Designer recommends installing decorative boarder to backer panel; masking VO inside decorative boarder, and painting the entire sign (face and returns) to match PMS 7540C

Graphics:

- Magenta band to be 1/2" PVC with faces and returns painted PMS 219C

Mounting:
