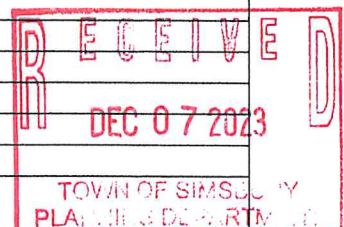

RE: New Business Signs for Dream3D

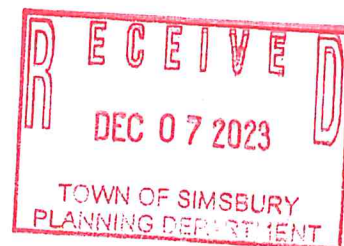
The protruding sign will be 116" from the ground at its top and at 24" diameter and projecting out from the wall 31" (see the photo of the X where it will be).

The other two signs will be above the two bay windows on either side of the door. They will measure 12 x 24" rectangle on the panel above the bay windows. The signs will be on the panel between 107" to 95" from the ground.

The three signs will be made from PVC material.
The colors can be seen on the attached pages (green).

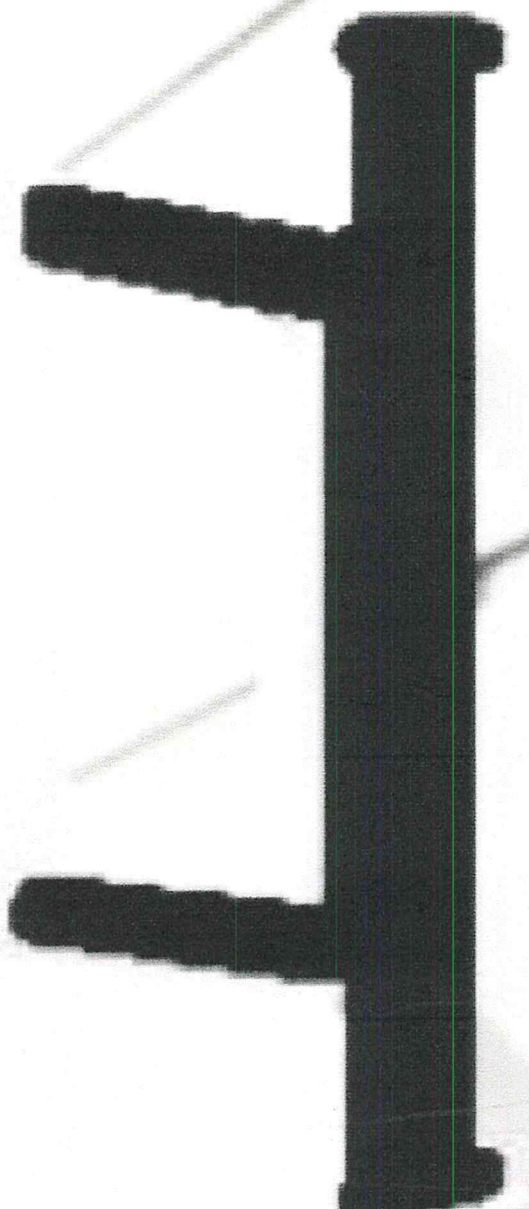
