CORONAVIRUS UPDATE

We are monitoring the state's municipal COVID alert system and are currently at "red" status for the period ending December 11th. Red status indicates that we have more than 15 COVID cases per 100,000 residents; we are currently at 39.7 cases per 100,000 people, an increase from 33.2 for the week prior. Over the most recent two-week period we had a total of 141 cases. Our positivity rate for the week ending December 11th was 7.1%, down from 7.2% the week prior.

FVHD is reporting that "we are experiencing some of the highest case rates seen throughout the entire pandemic. Increases are being seen in all age groups. Lack of mask wearing among both vaccinated and unvaccinated individuals in public places, social gatherings and dismissing symptoms and not getting tested are fueling the ongoing spread. Hospitalizations have also increased significantly." FVHD has said that CT has 40 confirmed cases of the Omicron variant, and that variant could become the dominant variant in the State of Connecticut in about a month.

As of December 16th, there were 710 hospitalized cases state-wide, of which 533 or 75.1% are not fully vaccinated. FVHD encourages individuals to get their COVID-19 vaccine as well as COVID-19 booster. Individuals seeking boosters may go to https://portal.ct.gov/vaccine-portal/COVID-19-Vaccination-Scheduling-Options

Data from the state ending December 15th reports that 21,380 Simsbury residents have received at least their first dose of the COVID-19 vaccine, or 84.19% of the population, while 76.94% of our residents or 19,539 people are now fully vaccinated. Further vaccination data for Simsbury by age group:

- Ages 5-11, 52.46% of those eligible have received their first dose, and 40.75% are fully vaccinated:
- Ages 12-17, 82.27% of those eligible have received their first dose, and 77.34% are fully vaccinated;
- Ages 18-24, 100% of those eligible have received their first dose, and 96.6% are fully vaccinated;
- Ages 25-44, 100% of those eligible have received their first dose, and 94.03% are fully vaccinated;
- Ages 45-64, 87.94% of those eligible have received their first dose, and 82.19% are fully vaccinated;
- Ages 65+, 100% of those eligible have received their first dose, and 100% are fully vaccinated

The ten towns comprising the Farmington Valley Health District constitute "high" risk for levels of community transmission based on CDC definitions (305 per 100,000), while the state of Connecticut and Hartford County are also at "high" risk. In areas with substantial transmission or higher, the CDC recommends that everyone (including fully vaccinated individuals) wear a mask in public indoor settings to help prevent spread of the virus and to protect others. Continued mask wearing in our municipal buildings helps to protect our staff to ensure that essential services (such as snow plowing) and infrastructure (such as our sewer treatment facility) remain open and operational for the public, amongst other factors. Therefore, we are continuing to require masks indoors at our municipal buildings at this time.

The following state-wide order still remains in place for indoor settings:

- Unvaccinated individuals must wear masks;
- Vaccinated individuals not required to wear masks except for below:
 - Masks are required to be worn by everyone in certain settings such as healthcare facilities, facilities housing vulnerable populations, public and private transit, correctional facilities, schools, and childcare
 - Private businesses and local governments have the ability to require mask wearing indoors at their facilities

FVHD is urging everyone to remind their employees, community members and others to do the following regardless of vaccination status:

- Stay HOME and isolate if you are exhibiting <u>ANY</u> cold like symptoms OR have been with others who are exhibiting symptoms
- Seek a test and isolate until test results are available
- Report positive results to employers and schools as appropriate
- If you are positive, seek guidance regarding isolation and quarantine from FVHD
