Budget Update

On February 27th, Town Manager Maria Capriola presented her proposed fiscal year 2019/2020 budget to the Board of Selectmen. You will find her budget presentation as well as the full budget, as proposed, here. The Board of Selectmen reviewed the proposed budget in detail and formally adopted it at the March 11th meeting. We are working on a citizens' guide to the budget which will be available on the Town website shortly. The goal is to provide a concise, digestible document, which improves public transparency of a complex document.

Other key dates in the process:

- Tuesday March 19th Board of Selectmen presents its proposed budget to the Board of Finance
 Tuesday April 2nd Public budget hearing at the library
- Tuesday May 14th Budget referendum at Henry James Middle School

Last month, Governor Lamont shared his proposed 2-year, \$43 billion budget with the General Assembly. Here is a good summary of the Governor's proposal from the Connecticut Mirror. Approximately 6% Simsbury's budget comes from state sources and the Governor's budget leaves Simsbury mostly whole when comparing funding levels to past years. In this Connecticut Mirror article, you can see what Simsbury and other towns in Connecticut would receive in the Governor's proposal. One area we are watching closely is a proposal that would require towns to pay for a portion of teacher pension costs. Our analysis shows that would cost Simsbury a little under \$250 thousand in the upcoming fiscal year with that cost increasing in future years.

It's important to recognize that the budget, when it's final, is likely to look different than the Governor's initial proposal. We are in close contact with Senator Witkos and Representative Hampton through this process.

State Legislation

Betsy Gara from COST and Amy Paterson with the Connecticut Land Conservation Council will be coming to our March 25th Board of Selectman meeting to discuss issues that are the subject of state legislation that may be of interest to Simsbury. I am also inviting Senator Witkos and Representative Hampton. The purpose of the conversation is to determine if the Board of Selectman wants to take a position to advocate for or against any of these proposals. Statewide issues with possible local interest include, but are not limited to proposals that would:

- Require towns to pay for a portion of teacher pension costs
- Compel the merger of smaller school districts
- Allow towns to impose a tax of up to 1% on property to pay for the acquisition or stewardship of open space
- Re-introduce tolls in Connecticut
- Allow for active management of our state's bear population

Planning Update

- A new restaurant will be moving into the 1820 House (former Metro Bis location). The new operator has filed for a special exception with the Zoning Commission to change the type of liquor license for the facility. This is scheduled for a public hearing on 4/1/2019.
- Landworks will be breaking ground on 48 townhouses associated with the Highcroft Development off Powder Forest Drive.
- I'd like to welcome LightHouse Design as a new business at 10 Jim Gallagher Way.
- 200 Hopmeadow Street (former Hartford property): The plan for the property consists of apartments, an assisted living facility, and some commercial development. Work has begun on one of two commercial buildings for the development. The assisted living portion of the development is scheduled to be open in late July/early August.

Old Growth Forest Network

Earlier this year, the Board of Selectmen voted unanimously for Belden Forest to join the Old Growth Forest Network. In doing so, Simsbury became the first community in Connecticut to apply for this designation. The mission of the Network is to designate at least one publically accessible forest in each county to become a future Old Growth Forest. The designation is not legally binding. It's a statement of intent to let the forest evolve naturally. Belden Forest will continue to have hiking trails that are maintained to provide for safety, and a formal dedication will be planned at Belden this fall.

On Thursday March 28th there will be the Connecticut Premier of "The Lost Forests of New England" at 7:30 pm at Cinestudio, 300 Summit St., Hartford. This 2018 film features stunning footage of rare Ancient Forests. The filmmaker will be participating in a discussion after the showing.

Discussion on Eating Disorders

The Community For Care is hosting a conversation on eating disorders, Wednesday March 13th, 6:30pm at the Simsbury Public Library. One of the panelists will be a local teenager and author of *Changing Ways*, a new book in which she shares her personal experience.

Alzheimer's Program

The Alzheimer's Association presents 10 Warning Signs of Alzheimer's, a program at the Simsbury Public Library, March 26th from 5:30 – 7:30. A light dinner will be served from 5:30 – 6. RSVP: 800-272-3900.

Safe Cities

Each year <u>Safewise</u> shares its list of America's 100 safest cities. This year, Simsbury ranked 30th on the list. Connecticut had 14 towns make the list; the second most towns of any state in the country. I am grateful for the work of the Simsbury Police Department in all they do around crime prevention in our community.

New Park Construction

In June, the town is scheduled to begin work on a new park next to the Flower Bridge. It will include new landscaping, paver walkways, and a new pavilion. This project will also improve access to the river for the launching of kayaks. While this park will enhance an already amazing attraction, the town will unfortunately need to close the Flower Bridge for much of the 2019 season. It will remain open until June to allow for the annual Duck Race and Burgers on the Bridge Fundraisers.

If you have questions about the new park or the bridge closure, I encourage you to <u>review a presentation</u>, which was recently delivered to the Board of Selectmen. The temporary closure of the bridge is not something we take lightly, but I'm very excited that we'll be able to unveil the new park in time for Simsbury's 350th celebration.

Snow Removal

I wanted to give a shout out to our Department of Public Works, which has the tough task of keeping our 170 miles of roads clear of snow and ice. Although winter is (hopefully) winding down, I wanted to share a neat opportunity to see first-hand what it takes to clean up after a winter storm. Here is a link to information about our <u>snowplow ride-along program</u>, which allows residents 18 and over the opportunity to accompany one of our plow drivers. I've done it myself and I highly recommend you avail yourself of this opportunity if you're interested. I will share that the experience was a lot bumpier and hotter than I'd expected!

I have been getting some questions this time of year about what residents can do if their mailbox is damaged by a snowplow. While it's relatively uncommon, the Board of Selectmen has adopted a policy that allows for the reimbursement of \$25 for the post and \$25 for the mailbox if the mailbox is physically struck by the plow.

Sustainable CT

At our February 11th meeting, the Board of Selectmen adopted a resolution joining the Sustainable CT program. It's an environmental certification program that towns can join free of charge. The part of the program I'm most excited about is the structure it will provide our town in the creation of a roadmap of projects to make the town more environmentally friendly. Deepwater Wind Solar Project

Development and Management Plans have been filed for the Deepwater Wind solar project with the Connecticut Siting Council. The D&M plan is essentially a detailed overview of how the 26.4-megawatt solar array will be built. Staff evaluated the submission and provided the Board of Selectmen an update at our meeting this week. While that update occurred in executive session, this project has tremendous public interest, so it's our intent to do a public presentation at an upcoming Board of Selectmen meeting this spring. - <u>The Simsbury Flea and Smorgasbord</u> features vendors and food trucks at Simsbury Meadows on Saturday April 27th.
- <u>The Simsbury River Run</u> is 5K and 10K road race that's taking place Sunday April 28th. There will be family activities at Simsbury Meadows where the race begins.
- The Simsbury Triathlon will take place May 5th. It includes a run, bike ride, and kayak portion. A duathlon (no kayaking) is also being offered this year.
- <u>The Valley Collector Club Car Show</u> will take place Sunday July 21st in the parking lots along Iron Horse Blvd.
- The Simsbury Woman's Club's 50th Arts and Crafts Festival will take place September 14th and 15th in the parking lots along Iron Horse Blvd.

HFPG Greater Together Listening Tour: The Hartford Foundation for Public Giving (HFPG) Greater Together Listening Tour event will be held this Thursday, March 14, at 5:30 pm at the Simsbury Public Library. The event is part of an information gathering program which will be used in the organization's strategic planning process. HFPG has held similar events throughout their service area over the past few months. HFPG President Jay Williams will speak. They wish to hear from community members what makes Simsbury great, some of the challenges facing the community, and how HFPG can work together with the town to make Simsbury an even better place to live. Results of the event will be shared on the HFPG website and we've requested they be sent to me directly as well. A new initiative of HFPG is the Greater Together Community Fund. \$100,000 has been set aside for each community in the HFPG area, \$50,000 to be used in the near future with the remaining \$50,000 held in perpetuity in an endowment for future projects. The towns will appoint a Community Advisory Group which will determine projects on which to allocate the \$50,000.
