Updates from our Budget Workshop Discussions

The updates on these two projects were discussed during our budget workshop on Sat, March 11th. They are BOS priorities and have run into some issues and are described below.

- Pickleball Courts in Tariffville are most likely going to be delayed a season, as we wait for the new and updated FEMA flood maps to become 'official'. The current maps have the proposed courts in a floodway, which prohibits us building new courts there. This project was funded and approved in the 2022/2023 Fiscal Year Budget. Given the delay, Culture, Parks, and Rec Director Tom Tyburski told us the town will add lines for the remaining 2 courts at the Farms, to add more courts. Stay tuned.
- Two of the stone pillars that we have leading into Simsbury, are moving forward with their replacement, but the Tariffville one has faced issues, given the proposed placement on state roads, according to Public Works Director- Town Engineer Tom Roy. This pillar funding was made available by the Simsbury 350th Anniversary Committee, who directly asked to fund a pillar replacement. We recommended using this funding for Tariffville. Stay tuned.

CRCOG FORUM on ECG/Multi Use Trail

The Capital Region Council of Governments has asked us to hold a forum to discuss the East Coast Greenway as it progresses and makes its way into Tariffville Center. This has been scheduled for March 30th in the Tariffville Cafeteria. Please join us if you would like to learn more about what is happening with the 3 sections of trail, connecting Tariffville to Simsbury Center, and Simsbury to Hartford.

CORONAVIRUS UPDATE

At this time, there are no counties in Connecticut considered to be "high" according to the CDC Community Levels categorization. In Hartford County, community levels of transmission are "medium", as determined by the CDC. The CDC recommends that if you are at high risk for severe illness, talking to your healthcare provider about whether you need to wear a mask and taking other precautions. The CDC has recommendations for <u>isolation</u> if you have suspected or confirmed COVID-19 and recommendations for <u>what to do if you are exposed</u> to someone with COVID-19. WINTER WEATHER UPDATE

Town staff is regularly reviewing and evaluating the impact of the anticipated storm. Should any delayed openings or closures of Town facilities be needed, updates will be provided through the Town website, e-subscriber notification system, and social media (Facebook and Twitter).

As a reminder, parking on public roadways is prohibited any time snow operations are in progress. Residents are also reminded to keep garbage and recycling cans out of the road and in their driveways to ensure that snow plows have clear road access. In addition, in order to ensure that fire department personnel can respond in the event of an emergency, residents are asked to clear snow away from fire hydrants.
