I continue to be deeply impressed by the preparedness and professionalism of our local government, first responders, and healthcare workers. Our Social Services Department has received donations of food and money from numerous individuals, businesses, and religious organizations. Town Budget

With everything else going on, our process continues to adopt a budget for fiscal year 2020/2021. The budget the Boards of Selectmen and Education sent to the Board of Finance keep taxes essentially flat in the coming year. If passed, as is, it would result in a small mill rate decrease, equal to about \$50 for the median valued home. We are aggregating budget information here.

Important dates in the process:

- May 5 Board of Finance holds a public hearing that will be closed to the public per the Governor's order, but public comment will be accepted in writing. Please send to ebutler@simsbury-ct.gov.
- May 30 budget referendum (if executive order is no longer in place)

<u>Coronavirus Update</u>: To keep our residents and employees safe, our town buildings remain closed to the public. Staff is working in our closed facilities on a limited basis, and we are continuing to operate by phone, mail, email and virtually through our <u>online services</u>. Urgent matters may be addressed by appointment, at the discretion of staff. Our Public Works, Parks, and Golf crews have modified their schedules and work practices to ensure that our critical infrastructure is maintained and fully operational.

During this time, staff has developed additional virtual and online services to better serve our residents. Examples include online Library programming, virtual fitness classes, virtual building inspections, and remote notary services. The Library has recently started to offer Remote Notary Service on Mondays through Fridays between 9:00 AM and 5:00 PM. Please use the following link to read the guidelines and access appointment information: https://www.simsburylibrary.info/services/notary-public/.

Our playgrounds, basketball courts, tennis courts, and paddle tennis courts remain closed. Our parks, open space parcels, and trails remain open for passive recreation such as walking, hiking, and cycling. Our parks and recreation team are working hard to maintain these spaces and keep them safe and accessible. People utilizing our parks should apply social distancing practices and keep safe distances from other patrons.

At this time the Transfer Station is temporarily closed. In order to meet the needs of our residents, both of our local trash haulers, Paine's Inc. and All Waste, have the ability to provide a second recycling bin, curbside bulky waste collection, and dumpsters upon request. Please call your hauler if you are interested in any of these services. For information on the disposal of paints and stains, visit the PaintCare website at Paintcare.org. If you believe you have an urgent disposal matter that requires immediate attention, please contact the Simsbury Department of Public Works at (860) 658-3222.

Our public meetings and public hearings remain closed to the public pursuant to an Executive Order issued by the Governor. This Executive Order is in place and has been extended through at least May 20th. Members of the public can submit comments in writing for meetings to Ebutler@simsbury-ct.gov. Residents may watch meetings of town agencies live on Comcast, Frontier, and online at www.simsburytv.org.

The Board of Selectmen at their last meeting adopted two property tax relief programs: a low interest rate program for delinquent payments and a property tax deferral program for eligible individuals. Information about these programs is available on our Tax Collector's website. We will begin accepting applications for the property tax deferral program on May 1st.

We are regularly updating the Town's website with information regarding changes to our municipal services, programs and facilities. We are also providing important information through our "news and announcements" emails and our Facebook and Twitter accounts.
