Both members of our legislative team at the capital are retiring from service.

State Senator Kevin Witkos announced a few months back that he was leaving the state senate. Kevin has been a great partner for Simsbury and worked in a bi-partisan manner to do what he felt was best for our district and his constituents. Thank you, Kevin.

And very recently, State Rep John Hampton announced that he would not be seeking reelection. I want to personally thank John for his service and representation of Simsbury in the CT General Assembly. He was always a good partner to the BOS, Town Hall and worked collaboratively with me as First Selectman. He also seemed to know and care about every single one of his constituents – I believe knowing them all by name! We wish you the best of luck, John!

I'm very happy to see that our budget passed on May 3rd. Thank you to the 1156 of you (out of 18,559) who came out to vote in person or by absentee ballot. It is everyone's right to vote and have a voice in how the town spends your tax dollars. I would have liked to see more people involved in the process, but we now have a 2022/2023 fiscal year budget that I'm very proud of. https://www.simsbury-ct.gov/finance/pages/2022-2023-budget-information

The Governor's budget was approved. There was a change in the final budget to use a vehicle mill rate of 32.46 – an increase over the originally proposed 29 mils. The state will offset this by providing towns with a Municipal Transition Grant. Simsbury will be receiving \$1,180,975 to offset the difference in our projected MV collection at our town mill rate of 37.41.

As May is Bike Month, please find the upcoming biking activities on the flyer provided in today's (May 9) agenda. The Board of Selectmen will be going on our annual Bike Month ride on May 19th, and you are welcome to join us. We will be meeting at Town Hall at 5:00 for an estimated 5-mile ride on the bike path.

Please also note the many bike partnerships with our library.

The ADU Opt out discussion that was scheduled for tonight has been moved to May 23rd so that members of the Zoning Commission can attend and answer questions. We are also open to hearing your thoughts on this topic via public audience as we this conversation moves forward.

The Town of Simsbury has an Anti-Harassment policy that states "we will not tolerate harassment as defined in this policy by anyone, including any supervisor, co-worker, vendor, citizen, resident, client,

or customer, whether in the workplace, at assignments outside the workplace, at Town-sponsored (social) functions." Besides Sexual Harassment, the following is addressed. I ask that those who come to speak to the BOS for Public Audience respect the town's policy.

B. Other Forms of Harassment Examples • Jokes about ethnicity, religious beliefs or practices, accents or gender-specific traits; • Repeated, unscheduled demands for attention and time regarding matters of a non-urgent nature that interfere with an employee's ability to perform his or her routine job duties in a timely and effective manner; • Any communication or action that is demeaning, rude or inflammatory or otherwise incites anger, hurt, fear or embarrassment in the receiver of the communication or action; • Unwanted questions or comments pertaining to any aspect of an employee's person or personal life; • Unwanted contact at an employee's home or in public when an employee is off duty. Examples of unwanted contact may include but are not limited to calling an employee at their personal cell phone or land line; emailing an employee at their personal email address; and physically approaching and/or berating employees about work matters when the employee is off duty.

CORONAVIRUS UPDATE

We are monitoring the state's municipal COVID alert system and are currently at "red" status for the period ending April 30th. This status indicates that we have more than 15 COVID cases per 100,000 residents. We are at 26.7 COVID cases per 100,000 residents. Over the most recent two-week period we had a total of 95 cases. We also had a positivity rate of 13.1%, an increase from the prior period's rate of 11.7%. As a reminder, this data does not include positive test results from at-home test kits.

All counties in Connecticut are considered to be "High" according to the CDC Community Levels categorization. The CDC recommends wearing a mask indoors, staying up to date with COVID-19 vaccines, and getting tested if you have symptoms when in a county with "High" community levels. The Town of Simsbury has a small supply of COVID test kits available for pick-up by the general public at the Simsbury Public Library, 725 Hopmeadow Street. Distribution will be limited to one test kit per individual per visit (each kit contains two tests). Kits will be distributed on a first come, first served basis while supplies last.

U.S. households can place a second order for free, at-home COVID-19 rapid tests (4 tests per order). The link to order is: https://www.covidtests.gov.

Data from the state ending April 20th reports that 22,723 Simsbury residents have received at least their first dose of the COVID-19 vaccine, or 89.48% of the population, while 82.86% of our residents or 21,043 people are now fully vaccinated. Additionally, 13,669 Simsbury residents, or 53.83% of the population, have received an additional booster dose. Further vaccination data for Simsbury by age group:

- Ages 5-11, 66.98% of those eligible have received their first dose, and 63.26% are fully vaccinated.
- Ages 12-17, 89.78% of those eligible have received their first dose, and 84.30% are fully vaccinated; 42.64% of the total population of Ages 12 17 have received an additional booster dose.
- Ages 18-24, 100% of those eligible have received their first dose, and 100% are fully vaccinated; 61.42% of the total population of ages 18 24 received an additional booster dose;
- Ages 25-44, 100% of those eligible have received their first dose, and 99.98% are fully vaccinated; 63.31% of the total population of ages 25 44 received an additional booster dose.
- Ages 45-64, 89.68% of those eligible have received their first dose, and 84.92% are fully vaccinated; 64.31% of the total population of ages 45 64 received an additional booster dose.
- Ages 65+, 100% of those eligible have received their first dose, and 100% are fully vaccinated; 92.03% of the total population of ages 65+ received an additional booster dose.
