2020 General Election

There are two ways to vote in the upcoming general election; in person on November 3, or by absentee ballot. Because of the Covid 19 pandemic, anyone can vote absentee this year. The Secretary of State's office has mailed absentee ballot *applications* to all registered voters. The applications can be returned in a pre-paid envelope or dropped off at Town Hall in the official election drop box. Ballots will be mailed out starting on October 2 to people who submit an application.

The deadline to register for the November 3 election is October 27, 2020. There is a seven-day registration blackout period before the election. If you miss the October 27 deadline, you may register and vote by personally appearing at your town's designated Election Day Voter Registration station. (Simsbury Public Library). Proof of identity and residence is required.

You can find many answers to your questions about the upcoming election on the <u>Registrar of Voters</u> page on the Town website. From that page you can confirm you're registered to vote, confirm your polling location, download and print an absentee ballot application, and more.

Simsbury SPIRIT Council

At the Board of Selectmen meeting on September 29, we heard a presentation from the SPIRIT Council, an organization that was formed to help Simsbury move forward on the path to becoming a more open, diverse, and inclusive community. You can view their presentation <u>here</u>. Deputy First Selectman Sean Askham and I will serve as co-liaisons to the SPIRIT Council, underlining the importance of this work. The Board of Selectmen unanimously passed a <u>resolution</u> declaring racism to be a public health crisis, and committed to 8 principles including becoming an equity and justice-oriented organization and capitalizing on opportunities to advance racial equity.

This Thursday, October 1, from 6:30 - 8pm, the SPIRIT Council is holding its third in a series of community conversations. In recognition of Disability Awareness Month, October's forum will focus on the experiences of individuals living with disabilities. The conversation will take place over Zoom and you must pre-register on the Library's website.

Updates from the Planning Department

- Construction on Big Y is progressing, and the store is scheduled for a soft opening the last week of October.
- The Zoning Commission has received an application for the development of a parcel that's currently vacant just west of the Hoffman dealership on Route 44. The application calls for the construction of a gas station and an electric car dealership, the first of its kind in Connecticut. The property was recently rezoned from residential to commercial.

Meadowood Conservation Purchase

I wanted to provide an update on the potential acquisition of a nearly 300-acre parcel known as Meadowood. On September 16, <u>the Board of Finance</u> heard a presentation from the Trust for Public Land, a nonprofit organization that the Town has engaged to assist with the purchase. To learn more about the history of the property and the potential acquisition, you can <u>view a presentation</u> on the Town website that's posted on the Open Space Committee's page.

The proposal calls for the preservation of more than 100-acres of farm land, nearly 140-acres that would contain recreational trails, the construction of athletic fields on a 24-acre parcel, and the preservation of historic barns and a Martin Luther King interpretive display. The Trust for Public Land continues to work to secure grant funding of approximately \$4 million. The Town's share would be approximately \$2.2 million. The project would ultimately need to be approved by the voters at referendum, which would most likely occur in 2021.

Simsbury Art Trail Extended

The Simsbury Art Trail, featuring 36 life-size statues, has been extended until October 5th. A closing ceremony will take place at the Simsbury Meadows Performing Arts Center on October 6th. Thank you to the Chamber of Commerce for organizing this spectacular trail and to the many individuals and businesses whose donations made it possible.

350th Anniversary History Walk

The 350th Anniversary Committee has unveiled a history walk: 350 Years of Simsbury in 350 Steps. Located along the Greenway next to the Performing Arts Center, the history walk tells the story of Simsbury with pictures, dates, and fun facts. The history walk is a collaboration with the Simsbury Historical Society, The Simsbury Free Library, and the Simsbury Meadows Performing Arts Center. Thank you to Big Y Foods, Liberty Bank, Mitchell Auto Group, and Elkinson + Sloves, who conceived and designed the history walk.

Because of Covid, the 350th Committee has had to reschedule and reimagine many of the planned celebrations. You can find the latest at <u>Simsbury350.com</u>. There is also an online store where you can purchase 350 merchandise including a copper plated commemorative medallion that features Simsbury's most iconic landmarks.

Hometown Heroes

Congratulations to our 2020 Hometown Heroes! Every year since 1986, the Town has celebrated its Hometown Heroes – residents who, through a deed or service make the town a better place to live. Each spring we accept nominations. Our ceremony was delayed this year because of Covid. Supporting our Food Programs

Simsbury Social Services has nearly doubled the number of households it's serving during the Covid-19 pandemic. Before the pandemic the Town was serving approximately 80 households per month with our food programs, which has now increased to about 140 households. Over the summer, we increased the frequency to every three weeks. Now that school has started, we've returned to monthly because of sustainability concerns and also decreasing the amounts of gift cards we are distributing.

Local families continue to rely on your donations. Donations of money will help us purchase gift cards for groceries as well as fresh produce for our distributions. Donations of gift cards are also appreciated. We are also seeking donations of non-perishable food items, household cleaning products, and toiletries. Our goal is to give everyone at least one full bag of items at each distribution, plus a bag of produce, and a gift card.

CORONAVIRUS UPDATE

Town Hall is welcoming back in-person visitors beginning Monday October 5th. During this next phase of re-opening, in-person visits to Town Hall can be conducted from 8:30AM to 12:00 PM on Mondays, Wednesdays and Fridays with the first hour of the day reserved for seniors from 8:30AM-9:30AM. However, the vault in the Town Clerk's Office will not be available for walk-in visitors until further notice. Town employees continue to report to duty at all locations, and are still available to schedule in-person appointments during normal business hours for services that cannot be completed by phone, mail, email, or virtually, please see a list of our <u>online services</u> for items and services that you can use from home.

The Library is also welcoming back in-person visitors on a limited basis. The Library will be open for inperson visits on Tuesdays and Thursdays from 10am-4pm, with the first hour reserved for seniors from 10:00AM-11:00AM. They will also welcome in-person visits on Saturdays from 9:30AM-1:30PM with no specific senior hours. Patrons may browse and check-out materials during their visit. One hour of computer use per person, per day and one hour of workspace use in the Business & Career Center per person, per day will be permitted. During all other times, the building will remain closed to walk-in visitors; services are available through <u>curbside pickup</u> for those uncomfortable coming into the building and reference librarians are available by phone Monday-Friday, from 10:00 am to 5:00 pm to answer questions

We are taking a cautious approach to reopening the Senior Center/Eno Memorial Hall to walk-ins in order to provide the greatest level of protection to the health and safety of our patrons. Eno Memorial Hall will remain closed for walk-ins until further notice. Public health is our predominant priority. Staff continues to reevaluate reopening plans in connection with the latest public health data and guidance from the Farmington Valley Health District and the State of Connecticut.

The Department of Community and Social Services continues its food programs, and is partnering with the Farmington Valley VNA to provide free weekly blood pressure and blood sugar screenings. Flu shots will be offered on October 8th and 22nd. The Simsbury Senior Center is pleased to announce that we will begin providing foot care and hearing clinics. Our foot care program will be running from 8:30AM to 2:30PM on the following dates: October 6th, October 7th, October 27th, November 3rd, and November 24th. Our hearing clinic will be running from 10:00AM to 12:00PM on October 19th, November 16th, and December 21st. Please call the Senior Center at 860-658-3273 to make appointments for both programs. All COVID-19 precautions will be followed and masks must be worn. Renters' Rebate applicants are encouraged to apply prior to October 1st. Applications for Energy Assistance will be accepted starting on October 1st; all applications will be taken virtually by phone, email, and mail.

As a reminder, the Board of Selectmen has extended the temporary suspension of cash payments through January 1, 2021 to help reduce the risk of spreading COVID. Payments can be made by check, debit card, or credit card. Checks may be mailed to the Town at 933 Hopmeadow Street, Simsbury, CT 06070 or left at our secure drop box at Town Hall.

The Transfer Station, playgrounds, basketball courts, tennis courts, skate park, golf course, parks, open space parcels and trails remain open. Social distancing is still strongly encouraged at these locations.

Meetings of town agencies will continue to be held virtually until further notice. Meetings are held utilizing Zoom and are broadcast on SCTV's television channels and SCTV's You Tube channel. Agenda items that are being discussed at a meeting will be posted online for the public to view.

We have received many inquiries from residents asking how they can help our fellow community members in need. Our Social Services Department is accepting donations of non-perishable food items, toiletries, laundry and dish detergent, baby items (wipes, diapers, baby food), kid friendly snacks, gift cards to grocery stores, gas stations, and laundromats, and financial donations for residents in need. The Town Clerk's Office will be mailing out all ballots on Friday, October 2nd for all applications received by this date. All applications received after October 2nd must be processed by the Town Clerk's Office within 48 hours of receipt. The Town Clerk thanks the voters for their support and understanding during this time.
