FIRST SELECTMAN'S REPORT

BUDGET UPDATE:

Last Thursday evening the Board of Finance approved the Board of Selectmen's Operating Budget of just over \$21 million and the Board of Education's budget of \$69.1 million, along with the Capital Improve Plan. The referendum is expected to be Tuesday May 1st. You can learn more about the budget and find a tax calculator on the Finance Department's page on the Town Website.

BOARD OF SELECTMEN BUSINESS:

Addition to the Agenda: Following the budget public hearing on Thursday evening, the resolutions needed to set the budget referendum date and formally approve FY 18/19 capital projects have been prepared with bond counsel's assistance. The following is being requested to be added to the agenda after the recognition of Mr. Kimball's service to our community:

This item can be added to your agenda this evening with a 2/3 vote of the body. The resolutions were emailed to you today and hard copies have been provided.

Executive Session for DWW: The Town Attorney does not have an update regarding Deepwater Wind. Therefore, the executive session scheduled for this evening is not needed.

"Non-Noticed" Meeting for Negotiations: Following adjournment of tonight's Board of Selectmen meeting, the Board will have a "non-noticed" meeting to discuss strategy related to negotiations with our police union for a successor collective bargaining agreement. Melissa and I have both received advice from the Freedom of Information Commission (FOIC) that strategy related to negotiations for collective bargaining is not an item under "executive session," but rather a topic that falls outside the definition of a "meeting." My understanding is that this is different than how the town has noticed this item on your agendas in the past. Please note that while FOIC has advised me in the past that we do not need to "post" for a non-noticed meeting, for transparency purposes I find it helpful to list the "non-noticed" meeting on the agenda.

Appointments: Late last week my office received a request to have multiple committee appointments added to the agenda. Additional information and/or work are needed on these appointments; I anticipate that they will be ready for the April 23rd meeting.

April 13th Special Meeting: As a reminder, there will be a special meeting of the Board of Selectmen this Friday, April 13th at 8:30am in the Main Meeting Room of Town Hall. The purpose of the meeting will be to present the Police Commission and Town Manager's recommended appointment for the Police Chief position and to approve the FY 18/19 budget mailer. The meeting will be properly noticed.

DEPARTMENTAL NEWS & NOTES:

Public Works: As part of his ongoing training related to his duties as Tree Warden, Director of Public Works Tom Roy recently took and passed the Supervising Forest Products Harvester exam through Connecticut DEEP. This certification is one step below a Forester certification and requires skill and knowledge pertaining to forestry harvesting including: applicable laws; timber harvesting techniques; environmental regulations; safety; and ethics. Congratulations Tom!

Town Manager's Office: Leadership Team Recruitments –

- First round interviews for Finance Director were conducted on April 4th. We are proceeding with next steps in the recruitment, with the second round of interviewing occurring the week of April 16th.
- First round interviews for the Director of Culture, Parks and Recreation are scheduled for April 23rd.
- The Police Commission is meeting later this evening to identify their preferred candidate for the Police Chief position, which will be formally presented to the Board of Selectmen at your special meeting on Friday.
