FIRST SELECTMAN'S REPORT

Multi-use Trail through Tariffville

The preliminary designs have been completed for a multi-use trail, a joint project between Simsbury and Bloomfield. The majority of the proposed trail will be located within the State Route 189 right-ofway and separated from the road by a roadside barrier system. The trail is planned to end at the intersection of Main Street and State Route 189 in Tariffville. This project is part of a larger effort to complete a multi-use path connection from the Farmington Canal Heritage Trail to the City of Hartford and points east as part of the East Coast Greenway. The East Coast Greenway is a continuous multiuse trail that will extend from Maine to Florida along the eastern seaboard. Construction is expected to begin in 2019.

Business & Development

The medical marijuana producer, Curaleaf, was granted a special exception for relocating its operations from 100 Grist Mill to 34 Hopmeadow Street. Curaleaf will be using the entire CL&P (Eversource) Building. According to the executive director, the company is planning on increasing its Simsbury workforce, which is currently about 38, and increasing capacity by about 40%.

690 Hopmeadow St (Ensign Mansion) was approved for a change in use. The change calls for a restaurant and office space on the first floor with 5 residential apartments on the second and third floors.

The property owner of 955 Hopmeadow Street has approached the Planning Office concerning opening the former Gibbs Mobile station. No applications are pending yet.

Economic Development Commission

The Board of Selectmen has formed an Economic Development work group to develop an ordinance to create an Economic Development Commission. We've been gathering input from members of the business community, residents who serve on boards and commissions, and other members of the public with an interest in economic development. On July 9th we will be sharing the draft ordinance with the full Board of Selectmen for their input. We are aiming to have the new Economic Development Commission in place this fall.

Eno Hall Renovations

Renovations are scheduled to begin Monday July 2nd at Eno Hall to improve the kitchen, construct additional storage space, and bathroom renovations. During construction, the lower level of Eno will be closed to the public. Parking in the rear of the building will be limited. The elevator and the existing handicapped accessible ramp on the north side of the building will remain open during construction. The first and second floors of Eno will remain open with access through the first floor entrance of the building. Carry In, Carry Out

With the warm weather upon us, a reminder that Simsbury adopted a carry in, carry out policy for trash in our town parks. That means anything you bring into the parks needs to be carried out. This policy was adopted about a year ago based on research that it's better for wildlife, prevents illegal dumping, and can play a role in making our parks cleaner. I have heard from some residents who have noticed an uptick in trash left on the ground, especially around Rotary Park. Since this policy is still relatively new, the Board of Selectmen has asked the Culture Parks and Rec Commission to monitor how it's working and provide any recommendations to improve it.

Depression in the Elderly Forum

The Department of Mental Health and Addiction Services (DMHAS) and State Representative John Hampton are holding a discussion on the issue of depression in senior citizens. Topics include warning signs, coping mechanisms and helpful resources available. It will take place **Wednesday June** $27^{\text{th}} 1 - 3pm$ in Program Room 2 at the Simsbury Public Library.

Hazardous Waste Collection
