Present: Robert Hensley, Gerry Toner, Tom Cooke, Cathy Barnard (until 8:25AM), Tim Pusch, Ed Kubasek, Ferg Jansen, Mike Pendergast(by phone)

CALLED TO ORDER: 8 AM by Chairman Hensley

1. The only agenda item was the review and possible action on the 2013 PAC Financial Report
2. Mr. Hensley gave an overview and update on Financials, the result of comparisons between the Town Finance Department and the PAC Manager's #s, adjustments made on both sides with input from Mr. Toner and Mr. Cooke as well as the meeting held Monday with Deb Sweeney of the Finance Department, Hensley, Toner, Cooke, and Jansen
3. The Board's sole charge is to report actual #s to the Board of Selectmen and honor the Manager's contract.
4. Discussion centered mainly on allocation of the Manager's \$19,800 salary on a fair basis.... 10 units weighted as follows:
 - 5 units TMMF
 - 2 units (1 each Harry Connick, Jr and Emmy Lou Harris)
 - 3 units SEPTEMBERFEST
5. Allocation of Sponsor payments was also discussed and no action resulted.
6. It was agreed that, going forward, having one set of books on an Annual basis will greatly simplify the process for the PAC 501C3 and the Town of Simsbury
7. Jansen moved and Kubasek seconded a motion: "To present the Financials with expense allocations as agreed upon and shown in the statements from the Finance Department dated 10-22-13. The motion was approved unanimously.
