Simsbury's Snow Plow Ride-Along Program:

The Town of Simsbury, Department of Public Works is offering the opportunity for residents to ride-along with one of our snow plows during a winter storm. There is no fee for the ride-along and all participants will need to be at least 18 years old and capable of climbing into the large truck.

How it works:

Interested participants can fill out an application with times that they are available to participate in the ride-along. Applications are available on the town's web site on the Public Works home page.

One or two days before a winter storm, town staff will confirm your availability for the anticipated storm and schedule a time for your ride-along. Participants will arrive at the Public Works facility at 66 Town Forest Road, where they will be given an overview of the town's snow plowing operations and a tour of the Public Works vehicle maintenance facility. Following the tour, the participant will meet the plow driver and climb into the truck. The ride-along will typically last 1 to 2 hours and return to the Public Works compound on Town Forest Road.

What to bring:

Participants should dress in comfortable clothes and stable footwear--boots are preferred. Layered clothing is recommended, as the cab of the plow trucks are kept very warm to minimize the ice build-up on the windshields (most of our drivers only wear a t-shirt or light sweatshirt while plowing).
