NOTICE OF BID

Sealed bids are invited and will be received by the Town of Simsbury, on behalf of the Simsbury Housing Authority, until 2:30 p.m., Thursday, November 9, 2017 in the Office of Finance, 2nd Floor, of the Simsbury Town Hall, 933 Hopmeadow Street, Simsbury, Connecticut, at which time and place they will be publicly opened and read aloud.

The work consists of removal and replacement of the underground oil tank at the Virginia Connolly Residence, and will include all material and labor to carry out the work.

Proposals must be submitted on the forms provided and in a sealed envelope plainly marked with the appropriate title.

A pre-bid conference to review the project will be held at the site, Virginia Connolly Residence, 1600 Hopmeadow Street, Simsbury, CT, 06070, in the 2nd Floor Multi purpose meeting room on Wednesday, October 25, 2017, at 2:00 p.m. All prospective bidders are urged to attend.

A satisfactory Bid Bond or Certified Check, in an amount equal to five percent (5%) of the base bid, shall be submitted with each bid. The Bid Bond shall be made payable to the Simsbury Housing Authority and shall be properly executed by the Bidder. A 100% Performance, Labor and Material Bond is also required. All sureties must be listed on the most recent IRS circular 570.

Attention of bidders is directed to certain requirements of this contract which require payment of Davis-Bacon wages, and compliance with certain local, state and federal requirements. This is a Federally funded project.
