CLEAN ENERGY TASK FORCE MINUTES October 19, 2011 REGULAR MEETING

The meeting was called to order at 7:00 p.m. by Chairman Boeshans in Room 103 of Simsbury Town Hall, with the following members present: Jim Ray, Susan Van Kleef, and Patrick Boeshans.

1. REVIEW AND APPROVAL OF MINUTES FROM MEETING ON OCTOBER 5, 2011 The draft minutes from the October 5th meeting were reviewed by all. Commissioner Ray made a motion to approve the minutes as written. Commissioner Van Kleef seconded the motion. All voted in favor.

2. PUBLIC AUDIENCE

Chairman Boeshans opened the floor for public audience. No comments were entered into the public record and the forum was closed.
